Kindly refer to your good office EDS raised online vide letter no. FC/HPB/04/2023 dated 21/04/2023 on the above cited subject, the reply has been submitted as under:-

- 1. All The components of the proposed project are marked in distinct colours in KML File and uploaded in the portal against column no. C. (ii) b.
- 2. Revised Layout Plan with correct dimensions of components is uploaded online web portal named as 'Revised Layout Plan' in additional information detail.
- 3. Necessary correction as been made in KML File and uploaded in the Portal.
- 4. TEC of the Project is uploaded in the additional information detail named as 'TEC of Sajla SHEP', And undertaking for IA is uploaded in the additional information detail named as ' undertaking for IA'
- 5. FRA Certificate with all prescribed annexures is uploaded in FCA web portal at Column no. K (i).
- Enumeration list of Trees mentioned in Check list no. 15 on each proposal folder at Page No. 44-46, total 5 number of trees coming in our project alignment and all trees to be felled. There is no possibility to reduce the felling trees to zero.
- 7. This point is pertaining to your good office please.
- 8. This Point is pertaining to your good office please. However It is also submitted that a small run of river hydel scheme and land use for the project is agricultural and barren forest land. Being a run of the river scheme, land submergence in not involved. The components of the scheme are mostly on the flat firm ground, and there is no danger of any erosion therefore there is no adverse effects due to the construction of project. It is also submitted that the Forest Advisory Committee in its meeting held on 11th May, 2022 held that "approval granted under the FC Act, 1980 for

mining project mostly carries conditions pertaining to preparation of Wild Life management or Soil and Moisture Conservation Plan by the State in consultation with the institute of repute". However, we undertake to pay the necessary fund for implementation of Wild Life Management or Soil and Moisture Conservation Plan if any required. Necessary undertaking is uploaded in additional information detail named as ' undertaking for WLMP and SMCP'.

- 9. It is also submitted that the Forest Advisory Committee in its meeting held on 11th May, 2022 held that "approval granted under the FC Act, 1980 for mining project mostly carries conditions pertaining to preparation of Wild Life management or Soil and Moisture Conservation Plan by the State in consultation with the institute of repute". However, we undertake to pay the necessary fund for implementation of Wild Life Management or Soil and Moisture Conservation Plan if any required. Necessary undertaking is uploaded in additional information detail named as 'undertaking for WLMP and SMCP'.
- 10. In this connection it is submitted that no Private Land available for muck dumping in the project cite. The check list no. 7 & 8 placed each proposal folder. Further it is certified that project is proposed there are no non forest land available in the area. Additionally, we certify that there are no trees present in our muck dumping site. The undertaking has been attached to this letter and uploaded in additional information detail named as 'Undertaking for not trees in MD Site.
- 11. In response to Point No. 11 (i) (ii) (iii) (iv), please find attached: (i) a list of approved/existing/commissioned SHEPs and the impact of the project, (ii) a digital map indicating the location of these HEPs and the distance from the nearest PA and Wildlife Sanctuary, and (iii) a certificate of approved capacity of the river/rivulet issued by the Project Officer HIMURJA. We have also uploaded these documents as additional information detail named as 'upstream and downstream Projects Digital Map'. Point no. (iv) named as 'River Basin Study' uploaded in additional information detail.
- 12. Please find the TEC and in TEC Point no XVI; Clearly mention the Evacuation plane of this project. Our proposed transmission line is underground and RoW of U/G Transmission line as taken of 0.6m and as well as mentioned in each proposal folder in check list no. 7 & 32 for you information please. The lenth of U/G Transmission Line is 426 m long and width is taken as 0.6 m.
- 13. Revenue maps (Tatima etc) of DA are uploaded in additional information detail named as 'Revenue record '.

In addition to this we have uploaded the FCA Proposal in Single PDF File in additional information detail named as 'Sajla FCA in Single PDF'.

In view of the above, it is therefore, requested to kindly accept the reply submitted and earlier action in this matter shall be highly appreciated.
