## DETAILED NOTE ON PROJECT

GAIL (India) Limited is the largest state-owned Natural Gas transportation and distribution company in India. It has following business segments: Natural Gas, Liquid Hydrocarbon, Liquefied Petroleum gas transmission, Petrochemicals, City Gas distribution, Exploration, Production and Electricity generation. GAIL (India) Limited has been conferred with the Maharatna status by the Government of India.

Overland transport of fuels by trucks is uneconomical, unsafe and is a contributor to environmental degradation in terms of pollutants released by vehicles in transit and by accidents and spillage. Pipelines are internationally recognized as the preferred alternative for transport of fuel for safety, economy and environmental friendliness.

GAIL has 6 LPG recovery plants across various states in India. LPG recovery plant at Usar was commissioned in 1998 with design capacity to process 5.0 MMSCMD of rich gas. Presently, LPG Usar plant is under shutdown and is in preservation mode due to non availability of rich gas.

GAIL (India) Limited has planned to establish 12" Dia. Uran - Usar Propane Pipeline along with OFC in Raigad district. As a part of the project, clean natural gas will be made available to various domestic, commercial and industrial customers across the districts, to achieve this, pipeline from BPCL Uran to GAIL SV Usar.

The proposed Uran - Usar Pipeline project shall benefit from the land in possession of GAIL as well as coastal location of the existing facility for both Propane Import, storage and product evacuation, nearby port facility, proximity to highways and ease for getting environmental clearance.

The proposed pipeline route tap off at BPCL Uran in Uran tehsil of Raigad district with starting point co-ordinates (Latitude: 18°52'34.975"N, Longitude: 72°58'22.807"E) and terminates at GAIL Usar in Alibag tehsil of Raigad district with end point co-ordinates (Latitude: 18°36'20.119"N, Longitude: 72°58'32.349"E) for the total length 45.453 Km in Maharashtra state.


