**Sub: Allotment of land in favour of M/s National Aluminium Company Limited (NALCO) for Over Land Conveyor (OLC) Corridor from Pottangi Bauxite Mines at Pottangi to Alumina Refinery of NALCO at Damanjodi, District: Koraput.**

Sir,

In inviting reference to the above subject, I am directed to inform you that the State Level Single Window Clearance Authority (SLSWCA) in its 110<sup>th</sup> meeting held on dated. 09/06/2022 has "In Principle' approved the proposal of M/s NALCO for setting up Over Land Conveyor (OLC) Corridor from Pottangi Bauxite Mines at Pottangi to Alumina Refinery of NALCO at Damanjodi, District: Koraput with an investment of 732.00 Cr. The company had applied 450 Acres of land for the proposed project. However, Sub committee of SLFC (State Level Facilitation Cell) assessed the land requirement to the extent of 310.5 Acres and SLFC in its 222<sup>th</sup> meeting held on 24.05.2022 has approved the same.

In view of the above, it is recommended for allotment of 310.5 Acres of land for the proposed OLC Corridor Project of M/s NALCO.

The required documents for processing the above proposal are available in the GO-SWIFT portal. However, the company may be asked to submit any additional documents if the same are not available in the GO-SWIFT site but essentially required for IDCO. The recommendation is subject to the following special terms and conditions in addition to the conditions of IDCO:

- The company will clear arrear dues if any, of any Government Department before allotment of land for the project.
- If construction work is not started within nine months from the date of possession, the lease shall be deemed to have been cancelled at the end of nine months period by IDCO  
Further, if the land or any part of it is not utilized fully for the purpose for which it is sanctioned within two years, the same shall be reverted to Govt/IDCO free from all encumbrances.
- The acquisition/alienation/allotment of land should be made as per relevant Act/rules of Government.

- The company has to obtain all statutory clearances/approvals for the 32 G2B services under the GO-SWIFT portal as mentioned in our letter communicated to the company vide IPICOL letter no. 
