Subject : Permission for laying of 8", 6", 4" steel gas pipeline by M/s. Bharat Gas Resources Ltd. along / across NH-50 (Bidar to Humnabad section) from Naubad circle to Dhumansur village from Km 54.370 to Km 90.200 (LHS) & from Km 90.200 to Km 96.450 (RHS) for a total length of 42.050 Kms by open trench method & two no. crossings at Km 56.260 & Km 90.200 by HDD method - Reg.

Reference: The Executive Engineer, NH Division, Kalaburgi letter No. EE/NHD/KLB/PB-2/NH-50/Steel gas pipeline/2020-21/1517 dated 25.02.2021.

Sir,

Please refer to your letter cited under reference, submitting the proposal seeking permission for laying of steel gas pipeline along / across NH-50 (Bidar to Humnabad section from Naubad circle to Dhumansur village from Km 54.370 to Km 90.200 (LHS) & from Km 90.200 to Km 96.450 (RHS) for a total length of 42.050 Kms by open trench method & two no. crossings at Km 56.260 & Km 90.200 by HDD method. The proposal is examined in light of Ministry's guidelines and permission is hereby accorded subject to following conditions:

- (i) The laying of Utility Services along NH shall be strictly at the extreme edge of ROW in accordance with approved drawing and as per Ministry's guidelines issued vide letter dated 22.11.2016.
- (ii) The Licensee shall strictly adhere to all the terms and conditions mentioned in the License Agreement.
- (iii) The laying of utility services shall invariably be at the extreme edge of ROW.
- (iv) As agreed by M/s. BGRL, isolation chamber with isolation walls, warning mats above the gas pipeline, sensors & gas leak detectors & other safety devices may be erected for the safety of road users. For any lapses in providing the required safety measures, M/s. BGRL will be held fully responsible.
- (v) The permission is valid for a maximum period of 5 years.
- (vi) Permission for laying of gas pipeline in the forest area stretches from Km 62.490 to Km 65.500 (3.01 Kms), from Km 69.600 to 69.650 (0.05 kms), from Km 69.650 to km 69.950 (0.300 kms), from 69.950 to 70.590 (0.64 kms) and from Km 84.400 to 86.540 (2.15 Kms) has to be obtained from the concerned Authority of Forest Departments before laying the gas pipeline.
- (vii) The Licensee is required to undertake restoration, maintenance work subsequent to laying of utility services at its cost either by itself or through its authorized representative in consultation with the Authority as per predetermined schedule and quality standards. This needs to be ensured by the Executive Engineer, NH Division, Kalaburgi.
- (viii) The performance bank guarantee as a security against improper restoration shall have to be valid till satisfactory completion of work. This needs to be ensured by the Executive Engineer, NH Division, Kalaburgi.

- (xi) The Licensee shall be liable to pay full compensation to the aggrieved authority / its designated agency for any damage sustained by them by reason of the exercise of the ROW facility.
- (x) The Executive Engineer, NH Division, Kalaburgi, shall issue a completion certificate after ensuring that the laying of the utilities has been done as per approved drawings and after completion of the restoration work as per Ministry's standards. The utilities shall be made operational by the Licensee only after the receipt of completion certificate.
- (xi) Notwithstanding anything contained herein, this Agreement may be cancelled at any time by Authority for breach of any condition of the same and the Licensee shall neither be entitled to any compensation for any loss caused to it by such cancellation nor shall it be absolved from any liability already incurred.
- (xii) Further, the bank guarantee submitted along with the proposal is valid upto 14.07.2021 and hence, the validity of the bank guarantee needs to be extended. The License agreement duly signed by the Competent Authority shall be issued after receipt of the extended bank guarantee. Extended Bank guarantee amounting to Rs. 1,07,31,250/- valid upto 14.07.2022, taken in the name of the Regional Pay & Accounts Officer (NH), Bengaluru needs to be submitted immediately.
