Subject :Permission for Laying 30"/24"/18"/12" Diameter Gas Pipeline (along with OFC/Duct) through Forest land falling across various utilities such as Roads, Canals, Rivers etc. and pipeline RoU proposed Phulpur-Haldia/ Dhamra Pipeline Project in the state of West Bengal.

Dear Sir,

GAIL (India) Limited has been authorized by Govt. of India vide letter dated 14.03.2016 to lay, Build and Operate a cross country Gas pipeline from Phulpur (Uttar Pradesh) to Haldia (West Bengal) / Dhamra (Odisha) including associated Spur Pipe lines. The said pipeline shall be passing through the states of U.P., Bihar, Jharkhand, West Bengal and Odisha for supply and distribution of Natural Gas / RLNG to various industries and City Gas Distribution networks. About 550 Kms pipeline shall be laid in the state of West Bengal. Accordingly, GAIL has to start pre-project activities immediately and pipeline is scheduled to be completed by 2019.

The proposed Phulpur-Haldia/ Dhamra Pipeline alongwith spurlines will be laid across forest land falling along / across various utilities such as roads, canals, rivers etc. and pipeline Right of User (RoU) en-route the pipeline falling under your jurisdiction in West Bengal state as per the location shown in the enclosed pipeline route map. The said pipeline shall be laid at the minimum depth of 1.2 mts. below NGL at utilities crossing points. The list of utilities/ crossings required to be crossed and list of villages en-route the pipeline is also enclosed herewith for your ready reference please.

In order to grant permission / NOC to lay the subject pipeline, statutory charges, if any such as Security Deposit, Govt. Fee etc. shall be deposited in advance by GAIL on demand from your end. During the execution of work, proper safety precautions will be ensured and area shall be restored back to its original

In view of the above, it is requested to verify the proposed pipeline route to identify the forest area falling under your jurisdiction so as to submit the online application and accordingly for grant of permission to lay the said pipeline.
