The forest land over 4.495 ha proposed for diversion is essential for construction of 132 KV single Circuit Transmission Line from 132/33 KV GIS Sub-Station Khuntuni OPTCL to MRSS of M/s Odisha Cement Plant(A unit of Shree Cement Ltd)At-Chandabalishyampur,Athgarh Cuttack. The main purposes is to supply of power for running of the plant as well as water and other components of the project. The back ground of the project is for production of PPC , OPC and PSC cements which will meet the public demands for construction works of buildings, roads, bridges as well as multifarious developmental activities both in Govt.and private sectors in and out of the state. This project also provide for employment of various categories of technical and non technical personnel as well as periphery development of the local people. However in view of enforcement of Forest Conservation Act,1980, the Project Proposal is recommended for obtaining necessary approval from Government of India, MOEF & CC.
