Short Note

(Regarding violation of Forest (Conservation) Act, 1980)

Urmodi big project or scheme in Satara district was constructed as mud Dam. It is tributary of Krishna River Under the same project, about 5 km south of Urmodi Dam. off socks Ambale (Dist-Satara) near the Nala Karahina Ambale earthen dam (complementary reservoir) make is proposed

The project is under Maharashtra Krishna Valley Development Corporation, Pune, under the "rest of Maharashtra Region" The Urmodi Irrigation Project contemplated to provide irrigation facility to the command area of 83000 ha in Satara Taluka, and 9725 ha each of Khatav and Maan Taluka which is a drought prone area. Total 27750 ha. in Satara Dist. will benefit through flow and lift irrigation. As major of project falls under drought prone area of Satara Dist. So this Project is included under Central Govt." **BALIRAJA JALSANJIVANI SCHEME**

The details of the original administrative approval of the Urmodi major project Govt. Resolution No. URM / 1081 / 231(2350) AIR (I) , dt. 25.6.1981

As proposed project is supply of water through gravity pipeline needs different size from 50 mm to 1600 mm dia. P.C.C. P. / B. W. S. E/ H.D. P. E. type pipeline. So detailed contour survey has been done and it is observed that the underground pipeline will be passing through 25 forest patches in 8 villages the total 28.297 ha forest land and 428.266 ha non-forest land required for this proposal For laying underground different dia. Pipeline digging of trench width will be approx. one and half time of wide dia of pipeline & depth is as per level for easy flow of gravity water. The material dogged out will be placed on one side of trench and to carry the heavy pipe required about 6 to 9 mt wide temporary carriage way for carry and fitting. Pipe by crane, so the width of forest land required for laying underground pipeline varies 10 mt to 20 me wide. After completion of laying the pipeline, the trench will be refilled again. As per need stop valve, sluice valve, scour valve, pressure relief valve and air volve will be fitted to pipelines as per requirement.

User Agency has submitted proposal to Forest Dept. and Govt Of Maharashtra has recommended and forwarded proposal record to IRO office

under MoEF & CC at Nagpur. and IRO office has requested to comply on shortcoming in the project

Meanwhile Urmodi Dam work has been allotted to IHP Company Miraj, and In Mhaswad village the contractor has started work in the non-forest area and about 690 mt long x 1.20 mt wide trench has been dogged by contracted. This work in forest has been done due to misunderstanding of forest and Non-forest land. This work was no done by deliberately by contractor. User Agency has given written letter not to violate the forest law and also not to do start work in forest area. Work has been stopped as per instruction of Forest Guard, Mhaswad. Hence there is no need of take action on responsible person / offices of Project Agency or Forest offices responsible for violation of forest law and rules. The detailed inquiry of forest offence has been done by Inquiry office and the case was compounded by authorised officer. Contractor has deposited amount Rs. 45109/ as compensation against offence by the pavti no 0010221 dt. 22/02/2023. now forest offence has been closed by forest dept.

As the above facts there is no need to act against officers /staff of user Agency and forest offices for the violation work in forest land.

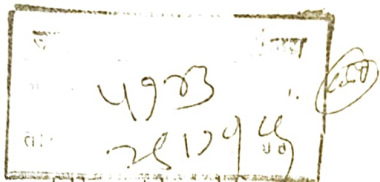


