1. From Karaknalli village to Humnabad Sub-Divn. Border Ch: 119.50 to 123.30 (SH-122) .(3800 Mtrs) .

TERMS AND CONDITIONS:

- 1. The proposed OFC cable, is to be laid sufficiently away from the ROW i.e., as per MDR/SH .norms and 1.65 mtrs below the existing Ground level.
- 2. No damages should be caused to the road while laying the Cable.
- 3. At Railway crossings, provide suitable size pipe and proper restoration to be done.
- 4. Safety precautionary measures should be taken while laying the cable.
- 5. If any damages or accidents takes places, owner will be held responsible.
- 6. No inconvenience to be caused either for public or for free movement of the vehicles.
- 7. No damages should be caused to any of the existing under ground utilities, such as water supply pipe line, UGD Line, Telecom service line and electric cables.

- 8. In case of any expansion of the road, upon notice to the party OFC cable should be shifted to a safer place totally at the cost of the owner.
- 9. Proper restoration should be done after laying the OFC cable.
- 10. For the road crossings, HDD method should be adopted compulsory.
- 11. It is permitted to carry out the work by only H.D.D.method to excavate the pits allowed upto 200 meters centre to centre 1.5 mtr to 1.50 mtrx 1.65 mtr depth. It should be restored as it is in previous condition. The said work should be executed as per IS standard.
- 12. The undersigned has got every right to cancel the permission without giving any prior information if deemed necessary.
- 13. Intimation is to be given to Asst. Executive Engineer concerned before one week from the commencement of work.



With reference to the captioned subject, Right of Way Permission for laying of Optical Fibre Cable (OFC) in Bidar – Chincholli Road for a total length of 16.50 km (from Tumkunta village to Changler/ Kanakalli Cross for a length of 7300m and from Kollur Cross to Chincholli Ambedkar Circle for a length of 9200m) is hereby approved, subject to the following conditions:

- 1. Trenching and HDD pits for laying UG cable shall be done on Extreme edge of ROW along the project road.
- 2. In village/town locations, the cable should be laid at the outer edge of the concrete drain and in rural locations, the cable should be laid beyond the earthen drain.
- 3. During laying of cables, the shoulder and the Asphalt surface should not be cut or damaged and pavement structure should not be disturbed.
- 4. The pits dug for drilling, shall be refilled in layers & compacted properly.
- 5. The trench excavated for laying cables shall be refilled in layer duly compacted.
- 6. After completion of laying OFC, the debris, waste materials etc., shall be removed from the road boundary.
- 7. All precautionary measures shall be taken before excavation so as not to affect the movement of traffic and safety of Road Users.
- 8. In high embankment portions the OF cable should be laid at the toe line i.e., bottom edge of embankment slope.

- 9. Neither KRDCL nor PWD will be responsible for shifting of cables under any circumstances and the cables shall be shifted at your cost only.
- 10. KRDCL will not be responsible for any shifting or damages caused during widening of road, repairs and other road improvement and maintenance works.
- For any damages to the adjacent drains, shoulder, carriageway or structures, during laying of cable the applicant will be held responsible and same will be rectified at his cost.
- 12. The work should be carried out under the supervision of the KRDCL Engineers incharge of the work.
- 13. The date and time of commencing the work should be informed to the Executive Engineer, KRDCL, Project office, Kalburgi well in advance. The work should be completed within 3 months from the date of this order.
- 14. In the event of any deviation, the work shall be stopped and the agency will be liable for penalty and forfeiting of the security deposit and charges will be levied. For any diverted length, laying operations should be allowed only after prior approval from KRDCL & depositing the restoration charges.


