



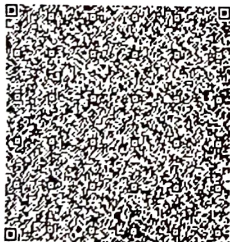

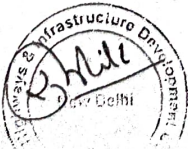

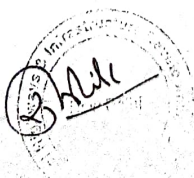

- (b) Client shall make payments to the Consultants in accordance with the provisions of the Contract.






