Sub:	Forests – Forest ( Conservation) Act, 1980 – Trichy Circle – Trichy Division – Proposal for diversion of 0.83916 ha of forest land for the use of drinking water to 135 habitations in Trichy district- Online Proposal Resubmitted by Assistant Engineer-Regarding

I have to state that the Forest permission for laying of pipeline to provide 135 Rural Habitations in Trichy District was applied thro online portal vide reference 1<sup>st</sup> cited.

Based on that proposal, your office letter reference 2<sup>nd</sup> cited was received and the reply is furnished herewith.

1. Component wise break up details of length, Breadth, and area in sq.m are now enclosed herewith and the same has been uploaded through online application.
2. The Administrative sanction and the Technical sanction of the above scheme are uploaded now thro online application.
3. In the initial (First) proposal totally 0.83916 ha of forest land was proposed to be diverted for villages as detailed below,
  - I. Pudhukottai – 0.0813 Ha for laying pipe line length of 1355 m and trench width of 0.6 m

- II. Marungapuri – 0.31002 Ha required for laying pipe line to a length of 5167.65 m and trench width of 0.6 m
- III. Nallur - 0.44784 Ha required for laying pipe line to a length of 7464.03 m and trench width of 0.6 m

During the execution of work the pipe line length along the forest area at Nallur village is only 550m as against the original proposal length of 7464.03m . Hence the area diverted to user agency is only 0.032 ha for Nallur village.

In addition to that pipe line for Water supply to the Kanjanaickenpatti and Kodumpapatti villages of this scheme noticed along the forest boundary area, and it also need to upload for the forest clearance to complete this project. Now the details of uploaded for forest permission of 0.49884 Ha as detailed below.

- I. Pudhukottai – 0.081204 Ha for laying pipe line length of 1353.4 m and trench width of 0.6 m
- II. Marungapuri – 0.276534 Ha required for laying pipe line to a length of 4608.9 m and trench width of 0.6 m
- III. Nallur - 0.032934 Ha required for laying pipe line to a length of 548.9 m and trench width of 0.6 m
- IV. Kanjanaickenpatti - 0.085134 Ha required for laying pipe line to a length of 1418.9 m and trench width of 0.6 m
- V. Kodumpapatti - 0.023034 Ha required for laying pipe line to a length of 383.9 m and trench width of 0.6 m

The above alignment lies along the road sides of existing village, State Highway roads only so there is no possible of flora and fauna affected. Hence I request to timely processed this proposal, so that water supply to the above villages are ensured on time.
