2.	As per linear plan & area calculation sheet uploaded in part-I, Kms-wise chainage viz Kms 0/00 to 1/100, the length has been taken NIL, whereas area is 0.28 mts (lhs) similarly from kms 1/400 to 1/500 length has been taken 60 mts. only instead of 100 mtrs., similarly other calculation has been done, which is not clear, needs to be clarified.	17.500, the entire alignment is in forest patch so, total area of the patch has been calculated and mentioned instead of right & left hand sides.
3.	NOC from Railway and Irrigation is not submitted.	NOC of the Railway has been obtained and the same is enclosed for information while NOC from Irrigation Department is in advance stage. An undertaking with regard to NOC from land owning agency is already
