Ramgarh district is the only district in the state where Police Line is presently functioning in temporary accommodation. The Ramgarh district was formed in the year 2007 and its collectorate building was constructed in Chhatermandu mauja. Chhatermandu is located close to Ramgarh town and is strategically located in the centre of the district for movement of forces all across the district. The Police line will have facilities for accommodation for the local and outside police forces, training facilities for police force etc, magazine for arms & ammunition which requires at least 13 hectares of land. This much GM land is only available close to the district collectorate in Chhatermandu Mauza and is ideal location for construction of Ramgarh Police Line. All the administrative offices like collectorate, district court, jail are either located here or nearby. In view of its location, it will provide administrative efficiency in police lines are constructed in Chhatermandu. Therefore, the construction of Police line in Chhatermandu Mauza is site specific considering its strategic location for controlling law and order in the district. The land is GMJJ and not a notified forest
