

In compliance of the Ministry of Environment and Forest (MoEF), Government of India's Letter No: 11-9/98-FC (Pt), Dated: 3rd August 2009 wherein the MoEF issued Guidelines on submission of evidence for having initiated and completed the process of settlement of rights under the Scheduled Tribes and other traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 on the forest land proposed to be diverted for non forest purposes read with MoEF's letter Dated: 5th February 2013 wherein MoEF issued certain relaxation in respect to linear projects. It is certified that **2.12 hectares** of forest land proposed to be diverted in favour of the District Panchayat Raj Engineer, Nirmal for the construction of road from **Kosagutta to Yapaiguda** in Nirmal District falls within the jurisdiction of Kosagutta & Yapaiguda GPs in Pembi Mandal of Nirmal District.

It is further certified that:

- a) The complete process for identification and settlement of rights under the FRA has been carried out for the entire **2.12 Hectares** of forest area proposed for diversion. A copy of records of all consultations and meeting of the Forest Rights committee(s), Grama Sabha(s), Sub Divisional committee(s) and District Level Committee(s) are enclosed.
- b) The Diversion of forest land for facilities managed by the Government as required under section 3 (2) of the FRA have been completed and the Grama sabha have given their consent to it.
- c) The proposal does not involve recognized rights of Primitive Tribal Groups and Pre-agricultural communities.


At the outset the District Collector & Chairperson for District Level Committee under RoFR Act, 2006 welcomed all the members for the meeting. The convener & RDO, Nirmal has appraised the fact of the proposals submitted by the Panchayat Raj Engineering Department, Nirmal for diversion of forest lands U/s 2 of Forest (Conservation) Act, 1980 for construction of the following Six Roads (06) works and One Bridge (01) work for which a certificate in Form-I from the District Collector, Nirmal is to be issued certifying that the process of settlement of rights under the RoFR Act, 2006 on the Forest lands proposed to be diverted for the said purpose have been initiated and completed.


The convener has also appraised that, the Villagers of concerned Gram Panchayats i.e., Kosgutta, Yopalga, Rasimatla, Korkanti Thanda, Laxmisagar, Vemkampochampad, Karnamloddi, Korkanti Thanda, Ankena, Kottamaddipadaga, Dildarnagar, of Pembli, Khanapur and Kaddam Mandals of Nirmal District gave their consent in writing for diversion of the said forest lands during the Gram sabha's conducted in their respective villages. Similarly, the Sub-Divisional level committee under RoFR Act, 2006 has convened its meeting on 06.07.2020 at O/o The Revenue Divisional Officer, Nirmal and passed resolution stating that there is no objection for diversion of the proposed forest land in favour of the District Panchayat Raj Engineer, Nirmal for the said purpose as there are no encroachments by the tribal people in the said land and further resolved that there are no claims pending to be settled under RoFR Act and unanimously resolved to forward the request of the District Panchayat Raj Engineer, Nirmal for consideration and issue of certificates in Form-I by the District level committee under RoFR Act, 2006.

The District Level committee unanimously resolved to issue certificates in Form-I under RoFR Act, 2006 for diversion of the said forest lands in favour of the District Panchayat Raj Engineer, Nirmal for construction of roads.



The District Panchayat Raj Engineer, Nirmal has informed that the road project **R/F Kosagutta to Yapalguda in Pembri Mandal** was sanctioned under PMGSY grant and few reaches of the road passes through forest for which Forest clearance is being sought from competent authority. Further, informed that as part of the clearance process, RoFR certificate from District Collector is required. The Tahsildar, Pembri has furnished a report vide his Lr. Rc.No.B/487/2020, Dt:14.05.2020 and informed that few RoFR certificates of Kosagutta and Yapalguda villages were identified along the road formation from Kosagutta to Yapalguda.



Further, the Tahsildar Pembli has informed that during the meeting held with these pattedars at Kosagutta and Yapalguda villages on 12.05.2020 they agreed and are willing to give their RoFR lands if the road passes through them in road formation from Kosagutta to Yapalguda and the statements of the pattedars are also recorded and submitted.

Accordingly, the Sub Divisional level committee has convened a meeting on .06.2020 at 3.00 Pm at RDO's office, Nirmal and unanimously passed resolution in favour of Dist. Panchayat Raj Engineer, Nirmal as there are no encroachments by the tribal people in the forest land to be diverted and further resolved that there are no claims pending under RoFR act to be settled. After through verification of all the evidences and reports of the Tahsildar, Pembli the Sub Divisional Level Committee hereby unanimously resolved to forward the request of the District Panchayat Raj Engineer, Nirmal for consideration and issue of certificate in Form-I by the Dist. Level committee under RoFR Act.
