1. PROJECT DETAILS:

i. Short narrative on the proposal and project/ scheme for which the forest land is required:

The proposed Bharatpur Expansion OCP lies in Kalinga east geological blocks which belong to MCL. Owner of the mine is Mahanadi Coalfields Limited (MCL), a subsidiary of Coal India Limited, a Central Public Sector company. MCL operates its coal mines within the State of Odisha, which has two major coalfields. Talcher & Ib-valley. Bharatpur mine is in Talcher coalfield, situated on the western part of Brahmani River, in the Mahanadi River basin. Bharatpur has proposed for a mining plan of 13.65 square kilometer of block area, out of which 6.81 square kilometer is approved & Mining Plan is ready. The Geological Report named "Revised Geological Report on Coal Exploration Bharatpur Reorganization Block" was prepared in February 2014 by CMPDIL on full payment basis from Mahanadi Coalfields Limited.

The net coal reserve in the proposed geological are is 828.826 Mt, out of which the approved blocked reserve is 213.656 Mt. Mineable coal reserve is 663.016 Mt, while the extractable coal reserve is 639.491 Mt. Coal reserve that is depleted is 231.833 Mt.

Jagannath open cast mine is on the eastern side of Bharatpur mine. Jagannath mine was going to be exhausted. In order to add life to Jagannath mine, a part of planned Bharatpur mine was transferred to Jagannath mine. In order to obtain environmental clearance for extended Jagannath mine, the boundaries of Bharatpur mine had to be adjusted as per new common boundary and obtain approval of revised mining plan.

Since Coal is site specific, the proposed expansion of Bharatpur OCP into Kalinga-east block with an additional area of 629.52ha which also involves 44.64ha of forest land is vital. Also to meet the energy demand of the nation and to narrow the demand-supply gap, the proposed expansion is required.

If analyzing on the cost benefit ratio, the project benefits Rs 18237,93,65,192.80/- to the nation's economy while losing an amount of Rs 142,20,54,599.72/- on grounds of Forests. So, the Cost - Benefit Ratio is 1: 128.25.

The total area of the proposed expansion mine is 1556.94 Ha out of which the total forest land is only 222.41 Ha. However, an area of 177.77ha has already been diverted for Bharatpur OCP. The proposed expansion is for additional area of 629.52ha which involves of 44.64ha of Forest land which is to be diverted. The location of the site for coal mining operation fully depends upon nature's deposit of minerals and geological structure of the coal seams. Hence question of exploring alternative site for the purpose does not arise.

- ii. Details of Forest area proposed to be diverted and already diverted:
- a) Forest Land already diverted: An area of 71.64 ha of Forest land has been diverted vide Stage II FC no. 8-348/98-FC dated 02.04.1997. Subsequently an area of 134.41 ha of Forest land has been diverted vide Stage II FC no. 8-87/2012-FC dated 07.02.2014. About 3.0ha of area is common/ overlapped in both the proposals.
- b) Forest Land proposed to be diverted: The total area proposed for expansion of Bharatpur OCP is 629.52 Ha, amongst which an area of 44.64 Ha of Revenue Forest land is involved which is proposed for diversion. However, DFO, Angul through EDS vide letter no. 9468/DRP/2022 dated 27.12.2022 has requested to revise the proposal including the sal forest of 13.09 ha over Govt. Non-Forest land in the diversion proposal owing to its dense vegetation. The total land proposed to be diverted is 57.73 Ha.

- iii. Details of Safety Zone proposed to be diverted and already diverted:
- a) Already diverted for safety zone and included in the proposal for change in land use for the purpose of Mining: An area of 0.18has has already been diverted for the purpose of safety zone in the diversion proposal of 134.41ha vide Stage II FC no. 8-87/2012-FC dated 07.02.2014. This area of 0.18ha is presently included in the proposal for diversion for the purpose of mining.
- b) Area proposed for safety zone: An area of 0.36ha of Revenue Forest land within the expansion mine boundary has been provided for safety zone and hence included in the diversion proposal for diversion of 0.36ha towards safety zone.
- iv. Compensatory Afforestation: For the purpose of creation of compensatory afforestation (double the degraded forest lands) in respect of proposals seeking prior approval of Central Government under Sec.2 of Forest (Conservation) Act, 1980, degraded forest area of 115.46 Ha. is required towards CA purpose for approving the diversion of 57.73 Ha. forest land situated in the expansion mine area. An area of 115.46 ha against twice the area of the forest land proposed to be diverted and an area of 0.54ha against 1.5 times of the forest land proposed to be diverted for safety zone is required for compensatory afforestation. Accordingly an area of 115.98 ha of degraded Reserve Forest has been identified in Dhenkanal Division and DGPS survey has been carried out by ORSAC. The details of CA land identified are given below:

vi: Justification for locating the project in the forest area:

The location of the site for coal mining operation entirely depends on nature's deposits of minerals and geological structure of the coal seams. The proposed area is a coal bearing area i.e Kalinga-East block duly notified by The Govt. of India and as such it is a site specific activity. The justification is also attached with the application.

vii: Cost Benefit Analysis:

The Cost Benefit Analysis is prepared as per the rules and guidelines with Cost-Benefit Ratio being 1:128.25. The Benefit to the economy is calculated to be Rs. 18237,93,65,192.80 with loss on forests estimated to be Rs. 142,20,54,599.72/-

viii: Employment likely to be generated:

The project is likely to generate direct employment of about 1093 persons in addition to indirect employment of about 3000 persons during mining operations and its allied activities.

ix: Villages Involved:

In the proposed expansion area, Nakeipasi (part), Niladripur, Teleipas, Khajuria, Solada (Part), Danara (Small Part), Joragadia (Part), Prasannanagar (Part), Kurihan (Small Part), Satyabadipur, Sarang. Kishorechandrapur are involved. The villages Nakeipasi, Teleipasi, Khajuria, Sarang and Satyabadipur are to be shifted fully.
