3.	Submitted Project Note not in prescribed format.	In order to keep the Project Note same for both the Forest Divisions (Osmanabad & Solapur) falling in our Project alignment, we have submitted Project Note under Certificate 40 similar to the one approved and forwarded to your office (being Nodal Division) by DCF Osmanabad. Kindly provide any additional details or Format of Project Note , for us to undertake required modifications, if deemed necessary as the same changes would be required to be done in Osmanabad Proposal as well.
4.	Requirement of signatures on submitted Typical Cross sections.	Complied. Signed copies of Typical Cross sections are submitted as Annexure-II.
5.	Submission of Administrative and Technical Approval docs for the Project.	Complied. Signed copies of Project Approval documents (Administrative and Technical) are attached as Annexure-III.
6.	Submission of Marathi and English translated 7-12 Extracts.	Complied. Marathi and English translated copies of Srvy No. 496 of Kasbe Solapur attached as Annexure-IV. Further, based on the list of all the Gut/Srvy Nmbrs falling in the project alignment submitted to your office, it was communicated vide your Ofc Ltr No. B/Desk-13/Survey/2409/2022-23 dtd. 16.12.2022 that Gut/Srvy Nmbr 165, 216 & 217 of Mardi village in North Solapur Taluka also belongs to Reserved Forest (RF) Category; although the JMS data & 7-12 Extracts doesn't reflect anything about those Gut/Srvy Nmbrs being Forest. Hence 7-12 extracts of Gut/ Srvy Nmbrs 165, 216 & 217 of Mardi village not confirming the legal status as Forest cannot be included in the Proposal.

		Hence, we request your office to provide supporting documents/notification, etc. as per your office record, confirming the legal status of these Gut/Srvy Nmbrs (165, 216 & 217) as RF for inclusion and onward submission with the Proposal.

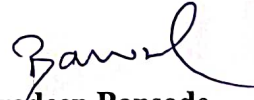
