2) Plantation Model:

Compensatory afforestation over an area of 8 ha. of degraded forest land is proposed to be raised. The area selected for this purpose falls under Deodar Selection Working Circle as per the prescription of the current working plan (2013-14 to 2023-24). Presently the area supports scattered Deodar, Kail and Fir trees. Whole of the plantation of 5.90 ha. will be raised in a single compact block inside the degraded forest for such purpose. The area identified for plantation has also been shown on the attached map. Plants @ 1000 plants per ha. will be planted. Thus, 5900 plants under this diversion proposal will be planted on the proposed site. The species to be planted will be mainly Deodar/Kail/Fir (*Cedrus deodara* / *Pinus wallichiana* / *Abies pindrow*) plants. The plantation will be raised in the following year after the approval of FCA proposal and further maintenance and beating up of failures will be done for the subsequent ten years. The scheme will be implemented by the Forest Department through Divisional Forest Officer, Bhadarwah Forest Division. The financial outlay for compensatory plantation scheme is Rs. **1249377.00**. Certificate of the DFO Bhadarwah regarding suitability of area identified for compensatory plantation is attached. The area selected for compensatory plantation will be approachable from existing proposed road. The monitoring will be done as per existing monitoring mechanism in the Forest Department at present and also as per G.O.I. instructions.

Technical Details: - Technical details of Compensatory Afforestation Scheme are as follows:-

- A) General Details:** - An area of 8 ha. Will be taken up for planting under compensatory afforestation scheme in forest compartment No. 4/N in a single compact block. The area will be protected by using square PCC fence posts with barbed wire fencing and by planting Deodar/Kail species plants. Plants will be planted @ 1000 plants per ha.
- B) Plantaion Method:** - Nursery grown two to three years old plants of Deodar/Kail species will be planted in the pits of size 45 X 45 X 45 cm in the selected area. The plantation will be maintained for subsequent 10 years in which beating up failures will be done. The plantation willrainfed.
- C) Spacing:** - 2.50 mts x 2.50 mts.
- D) Species proposed to be planted:-** Deodar/Kail (*Cedrusdeodara/ Pimuswallichiana*).
- E) Silvicultural Operations:-** NA
- F) Soil & Moisture Conservation Works:-** Minor Soil conservation works like gully plugging, check walls will be done where ever required.
- G) Protection:** (Fencing, Watch & Ward and People's Participation etc):- Area will be protected from grazing by erecting barbed wire fencing around the plantation site. Watch & ward shall be provided by engaging a watch man. Fire Protection shall also be provided by this watch man.
- H) Proposed Monitoring Mechanism:** - The plantation will be monitored as per existing monitoring mechanism in the forest department. The plantation will also be monitored by GOI representatives as per instructions.
