Subject: Construction of new bridges by Karnataka Road Development Corporation LTD

Read: 1. Announcement in budget speech in 2015-16

2. Letter of Managing Director, KRDCL, Bengaluru, No:KRDCL/MD/2015-16/326, dated:14-05-2015

Preamble:

- 1. Hon'ble Chief Minister, vide ref (1), in para-395 of the budget speech 2015-16, has announced that a scheme worth Rs. 1000/- crores for improvement of bridges connecting major roads would be taken up.
- 2. The proposals from Hon'ble Ministers, MLAs, Chief Engineer, Communications (South), Bengaluru & Chief Engineer, Communications (South), Bengaluru (North) have been received seeking construction of bridges across the state on State Highways. Major district roads and village roads by Karnataka Road Development Corporation Ltd., The construction of the proposed bridges provides connectivity among major cities, villages and backward regions, facilitates daily commercial activities, transportation of fisheries and agricultural production, educational development, provide connectivity to heritage temples & major tourist places, help local peoples to avail medical facilities. As such Managing Director, KRDCL, Bengaluru, vide letter under ref (2), has requested for sanction for construction of 386 new bridges at a line estimate of Rs. 2391.73 crores.
- 3. The above proposal has been examined in detail. A line estimate amount of Rs.1395.58 crores for construction of 195 bridges on priority is found necessary. Finance department has concurred for providing an additional amount of Rs.100 crores for the current year (2016-17) and has intimated for utilizing the balance amount of Rs.1295.58 crores in the grant

allocated to Public Works Department in next 3 years. Hence the following order.

4. The order is issued as follows:

Government Order No: PWD 34 EAP 2014, Bengaluru, dated:31-01-2017

- Administrative approval is accorded for construction of 195 bridges (as mentioned in annexure), which connects major roads in state, at a line estimate Rs.1395.58 crores on Turnkey basis (including Survey/Investigations, planning, design, drawing, estimate, execution, maintenance and handing over) by Karnataka Road Development Corporation Ltd.,
- 2. The construction of bridges shall be taken up on priority based on feasibility report and in accordance with Karnataka Transparency in Public Procurement (KTPP) Act 1999 and rules 2000
- 3. Finance Department has provided Rs.100 crores from supplementary Estimate-II for the construction of the above bridges. The balance amount of 1295.58 crores shall be utilised from the amount allocated to Public Works Department in the next 3 years i.e. Rs. 350 Crores in 2017-18, Rs. 450 Crores in 2018-19 and Rs. 495.58 Crores in 2019-20.

The aforesaid order is issued in accordance with the order of Finance Department No: FD 324 FC-I/2016, dated: 16-09-2016.
