- 1. Ensure that the embarrassment caused by optical cable is restored within 48 hours.
- 2. For laying optical cable, beam cut should be installed 1.5 meters away from the edge of paved road.
- Ensure that all the cuts/road cuts that are to be imposed by you are restored by your department as per the PWD specifications.
- 4. Safety of underground water supply and sewerage lines will be ensured during installation of optical cable and in case of damage will be immediately brought to the notice of the authorities and within 24 hours repairs/supplies will be guaranteed by the must

- 5. No more than 0.50 km of bore should be drilled for cable wiring, first work should be completed and restored at 0.50 km, then the next portion should be dug.
- 6. Laying of cable wire should not affect the perimeter and fixed width of the road, if a road cut is needed on the road, permission should be sought from the concerned Sub-Divisional Officer of this department and after making these road cuts in their presence/supervision, it should be ensured that the cut off section based on the specification of the road should be reconstructed by the concerned firm/department at its own level.
- 7. If the road section of the road is not reconstructed by the firm approved by you for work as per the specifications of the department, then your department will be bound to deposit the full amount spent on reconstruction with this office.
- 8. If any scheme is drawn up by the department/government for upgrading/widening the road in the near future, then your department will be fully bound to replace/remove the laid cable. This action will be taken by your department at your own expense and no claim will be taken from the department/government.

Your department will be solely responsible for road safety when laying cables. This means that there should be no obstruction to traffic on the road by your department. In case of any accident due to day and night work, it will be the responsibility of your department to provide the necessary road safety equipment/advance information equipment in working parts to facilitate the traffic.

- OF 110. If any unfortunate incident occurs during the work being done by you, then his department will be solely responsible for his/her full liability/financial reimbursement or reimbursement of any decision through judicial processes.
 - 11. If the Mandi Board is not satisfied with the work of Reston by the firm, then the concerned firm/your department will be bound to deposit the amount as per his BT bill.
 - 12. Special care should be taken on bridges, culverts, side drains and retaining valves in this cable wire alignment. That the purpose for which these structures are provided on the road should not be affected under any circumstances.
 - 13.  - 14. It will be the responsibility of the department/company to manage the traffic at the time of laying the cable and the required sign boards, speed limit boards, safety reflectors and safety ribbons will be installed by the department/company for the smooth management of the traffic.
 - 15. GPR survey should be done before putting underground blanket for paved route.

- 16. If an underground cable has already been laid on this route by a company like BSNL etc. Then coordinate with them before starting work, if the first cable is cut then your department/company will be responsible.
- 17. Inform the concerned Sub Divisional Officer before commencement of work and on completion of work.
- 18. This NOC is not in any legal interest.
- 19. The term of this NOC is 6 months from the date of issue. This NOC will expire after 6 months.

As per the terms of Serial No. 1 to 19 if your department uses any variability, then this NOC will be revoked, its rights will be reserved with this department/sub-signature.
