As per your request, Provisional permission for laying of water pipe line on Malout Fazilka Road MDR-40 Km 23.00 to 27.00 along with rajbah of DhippanWali to arniwala Sheikh Subhan is hereby granted subject to the following conditions:-

1. Pipe line should be laid at 4' the depth.
2. The Agency shall furnish a Bank Guarantee with a validity of one year initially. Therefore the Bank guarantee amount works out Rs.1,00,000/-.The Bank guarantee should be furnished in the name of Executive Engineer, Constn. Divn PWD B&R Br Fazilka.
3. In case any shifting or alteration in the position of the laid Pipe Line is required due to widening of highway and constructing of fly over bridges license will shift the same at his own cost at a later date within specified period.
4. Agency shall ensure safety and security of all underground installation / utilities facilities and shall be responsible for compensation/identifications of concerned authority for damage caused/claims or replacement sought for at the cost and risk of the Agency.
5. Agency will be liable to give a notice of 15 days with details prior to trenching for fresh or maintenance repair work shall be furnished by the Agency.
6. The clause of the agreement conditions should be strictly followed.
7. The Agency will fill and compact earth in layer 9" properly as per PWD specification in case of failure it will be done by the department at his cost and the cost will be deducted from the Bank Guarantee.
8. No damage to be done to the road or road berms except for which B.T. bill is already submitted.
9. In case of any damage to the plantation or any other property of Forest Deptt. The agency itself will be responsible for that.
10. Agency will take NOC from Forest Department and from other respective agency before starting work.
11. If any leakage is funded at any stage Agency will rectify at his own cost
12. Pipe Line should be laid at the PWD land limit i.e. at the end of land.
13. In case of any litigation/court case this permission shall be deemed cancelled.
