Sub: Request for clarification of co-ordinates to be in Drupang Reserved forest or in Itanagar Wild Life Sanctuary- Regarding

Sir with due regards, I on behalf of Power Grid Corporation of India Limited, would like to bring to your kind notice that Comprehensive Scheme (a Govt. of India project) for strengthening of Transmission & Distribution System in Arunachal Pradesh is being implemented.

In this regard, a 132 kV line is being proposed from Holongi (New) to 132/33 kV Chimpur (Existing) Substation of DoPAP. The line length is approximately 15.09 km which will traverse through Drupang Reserve Forest.

With your due permission vide your letter no: SUB/31/2008/3550-51 Dt: 26/12/2017 we have started detail survey for the said line and there has been a confusion regarding few co-ordinates whether they exist in Drupang reserved Forest or in the Itanagar Wild life Sanctuary. Details of the co-ordinates are as follows:

Inviting a reference to your letter under reference, it is to apprise you that the proposed location for Tower No. 1 to 3 falls under the excluded area of the Reserve Forest, Tower No 4 & 5 falls under the jurisdiction of Itanagar Wildlife sanctuary and from tower No 6 to Hollongi falls under Drupong Reserve Forest of this Division.

You are therefore, advised to submit diversion proposal as per F.C. Act 1980 for the stretch of proposed Transmission Line falling under Reserve Forest area for obtaining Forest clearance. Further you are requested not to take up any constructional activity prior to the clearance from Govt. of India under FC Act 1980.
