Dear Sir,

- 1) With reference to above subject, it is to state that, your requirement of additional power to the extent of 800 KVA, at 11 KV for your at existing unit raising contract demand 1200 KVA to 2000 KVA at Plot No. 7, Survey No. 91/, P4/7, Village: Zaroli City : Zaroli Taluka: UMARGAM District: VALSAD state: GUJARAT may be catered from the GETCO's by separate feeder / tapping ; Rural/Industrial/Urban Feeder.
- 2) The supply will be on contingent basis i.e. withdrawal at any time without notice, if the power position so warrants due to shortage of power as may be prevailing at the relevant times.
- 3) You shall have to enter into the firm agreement with the Company for the supply of power. You are requested to send fresh resolution of authorized signatory and list of the Directors along with their Temporary / Permanent, Residential address on Rs. 300/- Stamp Paper duly notarized.
- 4) If you fail to execute agreement within **15 days** from the date of payment of estimate, your application will be liable for cancellation.
- 5) Please execute agreement at Office of The Executive Engineer (O&M), Industrial Division, Vapi.
- 6) An estimate amounting to **Rs. 8891573 /-** towards Fixed charges (Non Refundable), plus **Rs. 4760103 /-** towards Security Deposit; to be paid by you, for supply of power to your existing unit located at Plot No. 7, Survey No. 91/, P4/7, Village: Zaroli, Zaroli and total amount **Rs. 13651676 /-** to be paid at the office of our **Executive Engineer (O&M), DGVCL, VAPI IND. DIVISION**, by Cash (up to Rs. 10000/-) / Demand Draft/Bank's pay order drawn in favour of the Dakshin Gujarat Vij Co. Ltd. payable at **Vapi** under intimation to this office. **The payment by Cheque will not be accepted. The detail break up of estimate is enclosed herewith.**
- 7) You shall have to pay **pro rata charges of Rs. 1024000 /-** @ Rs. 1280/ per KVA (Non-Refundable), in accordance with Commercial Circular No. ACE (R&C)/ EE-C/ DE-2/ 390 Dtd. 29.03.07 & Commercial circular 22 GETCO/CE(R&C)/685 Dtd. 03.04.2020 issued by The MD, GETCO based on GERC regulations at Sr. No. 4 & 5 under Notification No. 9 mentioned over and above charges at Sr. No. 6 by cash/Demand Draft/ Bank pay Order drawn **in favour of the Dakshin Gujarat Vij Company Limited** payable at **Vapi** under intimation to this Office. Since, the prorata charges are levied by GETCO, for convenience of consumer it is accepted by DGVCL. However same will be transfer to GETCO.

8) If the payment of this estimate along with Security Deposit is not received by **04-JUL-2021**, the estimate will be treated as cancelled and your application will be filed forfeiting the registration charge paid by you. No interest is payable by the Company on deposit collected towards service line charge.

9) This is only an approximate estimate and the final bill shall prepare on the basis of the actual work carried out plus labour and supervision charges. The work of laying the service line will be taken on hand only after you pay the estimate and execute the final stamped agreement at the **DGVCL, VAPI IND. DIVISION Office, Vapi.**

10) The service line notwithstanding that a portion of it would have been paid by you shall remain the property of the **Company** by whom it is to be maintained. Therefore the **Company** has the right to tap the service line for giving power to any other consumer, in accordance with provision of relevant I.E. Act.

11) According to the Rules & Regulations of the Company, you can utilize power received from the Company only within the compact area of factory premises not intervened by any public road or a private line belonging to a third party.

12) If your contract demand is 500KVA OR more, then you shall have to provide, install & maintain circuit breaker at the receiving end for receiving HT supply as per prevailing Rules & regulations of the Company. Specification of circuit breaker shall got approved by you from this end.

13) If you desire to install a Diesel Generator for use as a stand by supply to meet your essential load requirements in the event of failure of the Company's power supply to your installation, then you shall have to apply separately.

14) The Company gives the benefit of HT seasonal tariff to seasonal consumers such as Ice Factory, Ice Candy machines, Ginning & Processing Factory, Oil Mill, Rice Mill, Hullers, Salt Factory, Manufacturing starch, Sugar Factory, Cold Storage plant (including such plants in Fisheries industries). If you want to avail such benefit, then you may contact the office of the Executive Engineer (O&M) **VAPI IND. DIVISION, Vapi** before release of connection.

15) The Power supply if any exists in the premises prior to the release of the HT Power will be disconnected on the date of release of HT Power.

16) In case your requirement of HT Connection in the premises of existing LT Connection can be considered as conversion from LT to HT only when your power requirement demand under HT Connection is in the same name of your existing LT Connection in the same premises, otherwise your connection cannot be considered as LT to HT conversion.

17) Your estimate is issued in Single / group of ____ No. of applicants. You are requested to go through the condition of Annexure-D carefully and take necessary action accordingly.

18) Please note that once you have paid this estimate charges for the demanded load, you will not be allowed to reduce your demand for the period from the date of payment of this estimate till the expiry of new agreement period which may please be noted.

19) Before release of power supply, you shall have to provide a circuit and separate lighting meter at your cost, to record energy consumed by non-industrial load. If you are not providing separate meter for recording consumption of the lighting, 10% of total consumption recorded by TVM or as deem fit whichever is higher will be charged at the rate applicable to non-industrial consumption as per provision of tariff in force time to time.

20) If you want to avail HT power supply for a temporary period only then the tariff applicable will be HTP-3 and the consumer taking temporary HT supply need not enter into 2 years (minimum period) agreement you may therefore, inform us accordingly.

21) As per the notification No.3 of 2015, clause No.4.3 of Gujarat Electricity Regulatory Commission (security deposit) (second Amendment) regulations-2015, "The amount payable towards security shall be in the form of cash(up to Rs.10000/-) or demand draft (DD) drawn in favour of the licensee. The Consumer whose total amount of Security Deposit exceeds Rs. 25 Lacs may, at his option, furnish the security deposit in the form of irrevocable bank guarantee initially valid for a period of two years. Such bank guarantee shall be from a nationalized or scheduled commercial bank. It shall be the responsibility of the consumer to keep the bank guarantee valid at all times and to renew the bank guarantee at least 2 months prior to its expiry". Consumer having Security Deposit exceeds Rs. 25 Lacs, may submit the security deposit in form of bank guarantee in

22) You shall have to produce fresh No Objection Certificate for New HT connection as well as for additional load from the Gujarat Pollution Control Board (GPCB), Gandhinagar to the effect that the norms laid down by Gujarat Pollution Control Board, have been complied by you. Please note that site clearance certificate issued by GPCB will not be considered for release of supply.

24) Any way leave clearance, farmers objection and compensation shall be arranged by you.
