

OBJECTIVE :-

The main objective of the scheme is to compensate the loss due to the diversion of Forest Land and to afforest the area and protect the soil to prevent soil erosion besides encouraging ecological balance.

Scheme Proposals:

Activities proposed for treatment of non-forest land (4.73 ha)

The following activities are proposed for treatment of non-forest land over an extent of 4.73 ha in Sy. No. 19-2C2 of Ramagiri village of Ramagiri mandal of Ananthapuramu Range of Ananthapuramu District.

Sl.No.	Activity
1	Digging of CCTS of size 10 x 0.50 x 0.50 Mts with septa for every 10 Mts running trench including formation of mound.
2	Improvement to Natural miscellaneous growth including tending and cultural operations.
3	Construction of Check Dams.
4	Digging of Mini Percolation Tank / Percolation Tank.
5	Gap Planting

Treatment of degraded forest land (4.96 ha)

Technique:

It is proposed to raise the plantation by adopting the Labour Intensive Method over an extent of 4.96 ha in degraded forest land in Compt. No. 424 of Ramagiri East RF & beat with excavating the 0.45 M x 0.45 M x 0.45 mt size pits at 3 M x 3 M espacement. Tall plants of one meter and above height raised in 8" x 12" size bags will be planted. Basal dressing with Super phosphate @ 50 grams per pit and DAP @ 20 grams per pit will be done in the pits after planting. Circular weeding cum soil working is also proposed. Watering to the plants for 10 times during the non-rainy days is proposed. Fire tracing operations will also to be taken up. The plantation will be maintained for (10) years after raising.

PROJECT PERIOD:-

It is proposed to implement the scheme from 2022-23 to 2033-2034 over a period of (12) years.

FUNDING AGENCY:-

The total financial outlay will be met by the User Agency i.e., M/s Sri Vasista Mining , Hyderabad who will deposit the funds with the Forest Department.

EXECUTIVE AGENCY:-

The Forest Department will be the implementing Agency for this scheme.

FINANCIAL OUTLAY :-

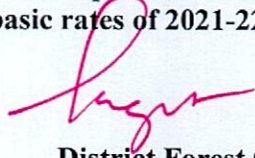
For treatment of 4.73 ha of non-forest land identified by the user agency i.e., M/s Sri Vasista Mining, Hyderabad in Sy. No. 19-2C2 of Ramagiri Village of Ramagiri mandal of Ananthapuramu Range of Ananthapuramu District and also Raising of Plantation in degraded forest land in Compt. No. 424 of Ramagiri East RF & beat under Labour Intensive Method over an extent of 4.96 ha, an amount of Rs. **35.60** Lakh is required. The User Agency i.e., M/s Sri Vasista Mining, Hyderabad has to deposit the Compensatory Afforestation amount, which will be utilized for Raising Compensatory Afforestation plantation in degraded forest land over an area of **4.96** ha and treatment of 4.73 ha of non-forest land identified by the user agency.

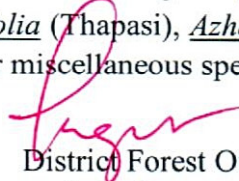
I have inspected the non-forest land over an extent of 4.73 Ha in Sy. No. 19-2C2 of Ramagiri village of Ramagiri mandal of Ananthapuramu Range of Ananthapuramu district in lieu of diversion of 4.96 ha (Mining & dumping – 4.16 ha, Safety zone – 0.75 ha & Road – 0.05 ha) of forest land in Compartment No. 200 of Bodabanda RF & Beat of Chittoor West Division, Chittoor District for grant of quarry lease for black granite on 07.06.2021 along with the Forest Range Officer, Ananthapuramu and concerned field staff.

The non-forest land extent of 4.73 ha identified by the user agency is adjacent to the C.A. land of other project i.e., M/s Sri Vasista Mining, Nandyal, Kurnool district (9.88 ha). The non-forest land is having natural miscellaneous growth with species of *Albizia amara* (Chigara), *Acacia sundra* (Sundra) and *Phoenix sylvestris* (Eatha). The site is suitable for taking up SMC works like Check dams, MPTs, CCTs and Gap planting. Wild animals like Black bucks, Peacocks and Deer's exists in the location.



Since, the non-forest land identified by the Use agency for C.A. is not suitable for planting, it is proposed to take up C.A. plantation over an extent of 4.96 ha in degraded forest land in Compt. No. 424 of Ramagiri East RF & beat which is equivalent to forest area proposed for diversion.

The soil is mostly red hard gravelly type and suitable for raising CA plantation with species like *Hardwickia binata* (Narepi), *Holoptelia integrifolia* (Thapasi), *Azhadiracta indica* (Neem), *Pongamia binnata* (Kanuga), Ficus species & other miscellaneous species.

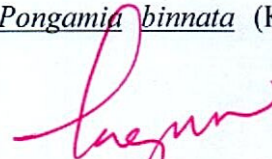
