Post facto Administrative approval is hereby accorded for execution of water supply scheme Upper Dandipopra for an amount of Rs. 216.00 lacs (Rupees Two hundred and sixteen lacs only) (Under NRDWP) in favour of Executive Engineer, Jal Shakti PHE Division, Bijbehara as per the general abstract of cost of the AAA.

However the Administrative Approval is subject to the following conditions:-

01. That Executive Engineer, will satisfy himself that the source proposed / selected for the scheme is dependable, perennial and free from all encumbrances.
02. That the design is with regard to PHE Manual.
03. That all BIS/IS codes and guidelines of CWC/CPWD are followed while formulating and implementing the project.
04. That all the items related to earth work shall conform to authenticated NSLs.
05. That the NOC from Forest, wildlife and R&B Department wherever required is obtained well before the commencement of works.
06. That any such items not covered under relevant schedule of rates shall be paid in accordance with the sweet Codal Procedure.
07. That the project drawing/layout plan/ design is approved by the competent authority before commencement of works.
08. That encumbrance free land duly authenticated by competent authority is available for the execution of project.
09. That there is no time of cost overrun involved in the project and set time line in respect of scheme is strictly adhered to.
10. Sustainability of source and quality of water shall be rechecked by Executive Engineer / Asstt. Executive Engineer before execution of works.
11. That the villages / habitations proposed under the scheme do not figure within the scope of any other ongoing scheme/project.

12. That the discharge available is adequate and will cater the need of the population for the entire designed period proposed to be covered under the scheme.
13. That the proposed scheme will in no way have any adverse impact on other existing scheme.
14. That e-tendering mode is followed for finalization of awards and working DPR's are followed in the advertised BOQ.
15. That the expenditure incurred on the scheme is restricted to the Budget provision from year to year and with the accorded amount of AAs.
16. That the works covered by this approval are allotted on most reasonable rates after completion of all the codal procedure requirements.
17. That the funds earmarked for the project shall not be diverted or parked in deposit just to avoid lapsing of funds.
18. That the geo-technical investigations are conducted wherever required.
19. That the officers of CGW/expert agencies shall have to be co-opted for ascertaining committed availability of water in the aquifer before attempting exploration of tube well.
20. That Technical sanction with respect to design specification is accorded by the competent authority after accord of Administrative Approval.
21. That the existing distribution network wherever rendered redundant is optimally relieved and accounted for.
22. That the project shall be subject to mid-term appraisal during execution by a third party / as per the guidelines of the programme and declared completed / commissioned after trail run and performance evaluation for at least one season.


Further, it is to be noted that the accord of project / AAA does not dispense with the working out detailed / most economical design of each and every component of the scheme.
