2.	Page numbering of diversion proposal has not been done which is required to be complied.	Complied.

In the online application Form-A in column " <u>L – Details of land identified for Compensatory Afforestation</u> " against which it has been submitted that "Not Applicable", which is required to be rectified / clarified. The details of non-forest / degraded Forest land identified for Compensatory Afforestation in lieu of such diversion of forest land is required to be furnished along with scheme	During online filing of the forest diversion application, in the column "L – Details of land identified for Compensatory Afforestation" on page-4, this section is non-editable by User Agency. However, when the Report of FC application is generated, in the mentioned column, it shows "Not Applicable", which is an auto generated answer. CA degraded land has been identified in




	of Compensatory Afforestation. The information furnished on the online application form and hard copy of same application seems to be contradictory and required to be clarified to this effect.	Siarimalia RF (170.40 ha.) and Madhi RF (210.916 ha.) under Kamakhyanagar West Range of Dhenkanal Forest Division vide DFO's letter no. 1095 dated 7.02.2017 (attached as <b>Enclosure I</b> ). The CA scheme shall be submitted to your office as soon obtained from DFO Dhenkanal.
4.	Cost Benefit Analysis has not been furnished in the prescribed format.	The Cost Benefit Analysis has been prepared in the format as prescribed by Govt. of Odisha as enclosed as Checklist No. – 12 of FDP. In case, the format of CBA is required to be updated, kindly intimate about the revised format.
5.	F.R.A. certificate is required to be furnished from the Collector concerned over the entire forest land proposed to be diverted along with Gramsabha resolution in Oriya and English version for inclusion in diversion proposal.	The F.R.A. process is in progress and the certificate shall be submitted as soon the same is obtained from the Collector of Jajpur District. Information regarding the same has been intimated to your office vide our letter no. NHA/2017/PIU/DKNL/646 dated 13.04.2017 (attached as <b>Enclosure II</b> ).
6.	Statements showing the land schedule both Forest Land and non-forest land involved in the project duly signed by concerned Revenue Official is required to be enclosed with the proposal.	Complied.
7.	Enumeration list of tree growths existing both in forest land and non-forest land involved in this project proposal is required to be enclosed with the proposal.	The range wise tree enumeration lists have already been submitted to your office vide the following letters (attached as <b>Enclosure III</b> ): 1. Office of the Range Officer, Dalijora Range memo no. 1694 dated 17 <sup>th</sup> October, 2013 2. Office of the Range Officer, Tomka Range memo no. 474 dated 16 <sup>th</sup> October, 2013 3. Office of the Range Officer, Sukinda Range memo no. 841 dated 16 <sup>th</sup> October, 2013
