- You are directed to furnish the progress of Establishment of plant and machinery, green belt, Effluent Treatment Plant and Air pollution control devices, by 10th day of completion of subsequent quarter in the Board.
- Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 31/12/2021 to the Board.
- Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution) Act, 1981 from the Board.
- It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
- Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

1. This Consent to Establish is granted for M/S Indian Oil Corporation Ltd, Khasra No.10, Vill-Mitai, Hathras-Agra Road, Tehsil & District-Hathras.
2. This Consent is valid for the Establishment of unit only. The industry can only manufacture products, at the rate of production as mentioned in consent order. In case of any change in production capacity, process, raw materials use etc. Industry will have to be intimate to the Board. For any enhancement of the above, fresh Consent to Establish has to be obtained from U.P. Pollution Control Board.
3. The height of stack attached to 15 K.V.A. D.G. set should be raise about 1.5 meter respectively from nearest roof top of the building
4. This consent is valid for Retail Out let of Petrol, Diesel Lubricant, Storage at a time Petrol 20KL, Diesel 20 KL Lubricant 1 KL.
5. The proposed retail outlet should be installed in such a way that the surrounding ambient air quality is not affected.
6. Septic tanks should be installed to treat domestic effluents generated from the proposed retail outlets.
7. Plantation of maximum number of trees should be done in the premises of the proposed retail outlet.
8. The proposed retail outlet should ensure compliance with the conditions stated in the No Objection Certificate received from the fire department and an on-side emergency plan should be prepared to prevent any accident.
9. Compliance with Hazard's West Rules should be ensured by the proposed retail outlets.
10. A system of rain water harvesting should be established through the proposed retail outlets.
11. Water / air consent should be obtained by the proposed retail outlet before its operation.
12. Vapor recovery systems should be set up for recovery of vapor borne by diesel / petrol storage by the proposed retail outlets.
13. Proper arrangements should be made to prevent MS / Diesel from spreading in any case by the proposed retail outlets.
14. Verification of the provisions of Plastic Waste Management Rules, 2016 should be ensured in letter and spirit.
15. Verification of provisions of Solid Waste Management Rules, 2016 should be ensured in letter and spirit.
16. Land use certificate issued from the competent authority level by the retail outlet should be sent to the office within three.

Please note that consent to Establish will be revoked, in case of, non compliance of any of the above mentioned conditions. Board reserves its right for amendment or cancellation of any of the conditions specified above. Industry is directed to submit its first compliance report regarding above mentioned specific and general conditions till 18/04/2020 in this office. Ensure to submit the regular compliance report otherwise this Consent to Establish will be revoked.
