


Subject:- Acquisition/ Allotment of land for construction of Govt Treasury at Bani.

Sir,

In reference to the subject cited above, it is submitted that presently the Govt Treasury Bani is being run in building of Niabat Bani as temporary measure since long. Subsequently, process for acquisition of 11 marlas of land was initiated and revenue papers were prepared. However, at a later stage, it has been observed that the land under acquisition for setting up of Govt Treasury has already been acquired by the Revenue Department and as such cannot be acquired. Letter of Tehsildar Bani vide No. 415/Gen/OQ dated 13-08-2016 is enclosed herewith. Moreover, the already proposed land is situated in the middle of Revenue Complex Bani and therefore it is not in the fitness of things to set up Govt Treasury there.

In view of the above, land measuring 01 kanal situated in village Kanthal has been identified and revenue papers have been prepared and are enclosed herewith for authentication. The papers should be returned to this office after due authentication at the earliest enabling this office to proceed further in the matter.




