It is informed that ETS & DGPS/GNSS Survey data, for proposed diversion of forest Land in favour of M/s Reliance Jio Infocomm Ltd, for laying of Optical Fiber Cable in the existing Right of Way falling in various forest divisions received vide references 4th to 10th cited has been verified and accepted at this stage with the extents detailed below. **The maps are enclosed herewith.**

It is further informed that the proxy RF boundaries depicted on topo maps are used for ascertaining the entry & exit points of alignment with RF. The division boundaries are ascertained with the help of available records. The extents of alignment passing through notified forests are estimated as detailed above. The User Agency has not proposed the width of the trench. Hence the area in each of the forest division is not estimated.

The concerned Conservators of Forests and District Forest Officers/Forest Divisional Officers stated above are being requested to verify absolute location of Points in field. They are also being requested to include/delete areas, if required, after verification.

In this regard, the User Agency is informed that piece meal proposals are being submitted in a single district/division, which is not permissible. The User Agency was already informed vide references 1st to 3rd cited to confirm whether these are only the areas required or any other areas also involved. However, the reply is not received in this regard and piece-meal proposals are again submitted.

The User Agency is once again requested to assess the entire requirement and prepare the phased program for submission of proposals in accordance with Para 4.4 & 2.2 of Handbook of F(C) Act, 1980 and the amendments issued therein for each division wise. Only after receipt of the detailed report from the User Agency, same will be examined and then only, the User Agency will be permitted to submit proposal with justification, for diversion of forest land as detailed above, and to upload the proposals online, as well as submission of (8) sets of hard copies for each forest division, together with all necessary documents/information.

Here it is requested to note that proposal(s), if any, received from the User Agency in future, for diversion of forest lands for laying of OFC, the same will not be accepted by this office, unless and until the User Agency submits detailed report as desired by this office. The alignment of entire division shall be furnished in a Kml/shape file format duly indicating the alternatives, if any, and also to certify that in case if the diversion of forest land is declined, they will follow the alternate routes selected in non-forest areas. The Kml/shape file can be prepared tentatively on Google Earth/topo maps to ascertain the length of the alignment passing through notified forests which will be informed then only conduct ETS & DGPS/DGNSS survey in consultation with DFO and submit the data for authentication of data by this office.

M/s Reliance Jio Infocomm Ltd is requested to pay an amount of **Rs.31,500/- (Rupees Three One Thousand five hundred Only)** towards verification and authentication of ETS & DGPS/ GNSS data in the form of a demand draft drawn in favor of "Joint Secretary, CEFNARM".
