Please find enclosed herewith a copy of letter No.3-ANB 023/2013-SHI/3321-22 dtd. 04.03.2015 vide which Ministry of Environment & Forests, Govt. of India, has conveyed its in-principle approval for diversion of 4.50 ha of forestland for improvement of Akajan-Likabali-Bame road from 65.00 km to 71.00 km by BRTF in West Siang Dist. of Arunachal Pradesh subject to fulfillment of stipulated conditions mentioned in the letter for your information and necessary action.

As envisaged in the GOI's above letter, you are requested to arrange to transfer the following amounts at an early date to enable this office to submit compliance report for obtaining final approval.

Further, you are requested to ensure compliance of all the conditions and submit necessary undertakings wherever required to this office immediately along with compliance report.


The amount at Sl 1 & 2 above totalling Rs.39,68,200/- (Rupees thirty nine lakh sixty eight thousand two hundred) may be remitted to the Corporation Bank, CGO Complex Branch, Lodhi Road, New Delhi 110003(RTGS/IFSC No.CORP0000371) for credit in S.B.Account No. - 1601CA 25199 through RTGS. In case, Corporation Bank facility is not available, you may transfer the amount through RTGS in Union Bank of India, Sundarnagar Branch, New Delhi-110003 (RTGS/IFSC No. UBIN0534498 and S.B A/C. No. 344902010105 408). A certified copy of the receipt of remittance may be sent to this office for record.

Similarly, the value of trees worth Rs.2,92,215 /- at Sl. No. 3 above may be transferred through Bank Demand Draft in drawn favour of " The Principal Chief Conservator of Forests, Arunachal Pradesh" payable at SBI, Itanagar Branch and send the demand draft to this office.

Also, it is requested not to break the forest land till final approval of the proposal is granted by the Central Govt. under the Forest (Conservation) Act, 1980.
