In the light of the provisions contained under the Forest (Conservation) Act, 1980, it is mandatory to raise Compensatory Afforestation Plantation in lieu of forest area proposed to be diverted. The user agency i.e., M/s Sri Vaishnavi Granites, Hyderabad, has identified non-forest land for C.A., over an extent of 4.95 ha in Sy. No. 103-2 of Ramagiri village of Ramagiri mandal of Ananthapuramu Range in lieu of diversion of 4.82 ha (Mining & dumping – 3.70 ha, Safety zone – 0.80 ha & Road – 0.32 ha) of forest land in Compartment No. 227 of Basavapalli RF, Chittapara beat of Chittoor West Division, Chittoor District for grant of quarry lease for black granite.

The non-forest land identified by the user agency i.e., 4.95 ha is having natural miscellaneous growth and suitable for taking up SMC works like Check dams, MPTs, CCTs and Gap planting etc.,

Since, the non-forest land identified by the Use agency for C.A. is not suitable for planting, it is proposed to take up C.A. plantation over an extent of 4.82 ha in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat which is equivalent to forest area proposed for diversion.

AREA :-

Since, the non-forest land identified by the Use agency for C.A. is not suitable for planting, it is proposed to take up C.A. plantation over an extent of 4.82 ha in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat which is equivalent to forest area proposed for diversion. The C.A. plantation in degraded forest land and treatment of non-forest land will be taken up with the funds deposited by the user agency. The degraded forest land proposed to be treated for C.A. is suitable for raising of plantation with species like *Hardwickia binata* (Narepi), *Holptelia integrifolia* (Thapasi), *Azhadiracta indica* (Neem), *Pongamia binnata* (Kanuga), Ficus species & other miscellaneous species.

OBJECTIVE:-

The main objective of the scheme is to compensate the loss due to the diversion of Forest Land and to afforest the area and protect the soil to prevent soil erosion besides encouraging ecological balance.

Scheme Proposals:

Activities proposed for treatment of non-forest land (4.95 ha)

The following activities are proposed for treatment of non-forest land over an extent of 4.95 ha in Sy. No. 103-2 of Ramagiri village of Ramagiri mandal of Ananthapuramu Range of Ananthapuramu District.

Treatment of degraded forest land (4.82 ha)

Technique:

It is proposed to raise the plantation by adopting the Labour Intensive Method over an extent of **4.82** ha in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat with excavating the 0.45 M x 0.45 M x 0.45 mt size pits at 3 M x 3 M espacement. Tall plants of one meter and above height raised in 8" x 12" size bags will be planted. Basal dressing with Super phosphate @ 50 grams per pit and DAP @ 20 grams per pit will be done in the pits after planting. Circular weeding cum soil working is also proposed. Watering to the plants for 10 times during the non-rainy days is proposed. Fire tracing operations will also to be taken up. The plantation will be maintained for (10) years after raising.

PROJECT PERIOD:-

It is proposed to implement the scheme from 2022-23 to 2033-2034 over a period of (12) years.

FUNDING AGENCY:-

The total financial outlay will be met by the User Agency i.e., M/s Sri Vaishnavi Granites, Hyderabad who will deposit the funds with the Forest Department.

EXECUTIVE AGENCY:-

The Forest Department will be the implementing Agency for this scheme.

FINANCIAL OUTLAY :-

For treatment of 4.95 ha of non-forest land identified by the user agency i.e., M/s Sri Vaishnavi Granites, Hyderabad in Sy. No. 103-2 of Ramagiri Village of Ramagiri mandal of Ananthapuramu Range of Ananthapuramu District and also Raising of Plantation in degraded forest land in Compt. No. 420 of Ramagiri West RF & beat under Labour Intensive Method over an extent of 4.82 ha, an amount of Rs. 35.50 Lakh is required. The User Agency i.e, M/s Sri Vaishnavi Granites, Hyderabad has to deposit the Compensatory Afforestation amount, which will be utilized for Raising Compensatory Afforestation plantation in degraded forest land over an area of 4.82 ha and treatment of 4.95 ha of non-forest land identified by the user agency.


