At the outset we thank your office for the kind support in processing our application offline during 2018 and the kind consideration by the department. This is part of the clearance taken for the entire forest stretch covering Tamil Nadu and Karnataka, inadvertently. It covers both states and was deliberated at all levels of the state government along with the project construction issues. Accordingly, the department perused the case in detail and recommended the same to government, after examining all drawings (kml, Autocad, etc), DCF & CF recommendations vide letter dated 19.07.18, copy enclosed as Annexure -1.

Subsequently, vide ref (i) above forest clearance application under FC Act 1980 was submitted and its was accepted in complete shape vide email dated 28.08.20 with an advice to submit hard copies to field offices, copy attached. Accordingly, we have submitted the copies for this narrowly passing line; 43.2m (0.2765Ha) through Banthanal State Forest within BNP. This is in Sy.No 67 of Yelachavadi Village, Maralavad Hobli, Kanakapura Taluk, Ramanagara District, vide ref (iv) & (v) above. Now vide letter ref (vi) it was communicated by your office to revise the area from 0.2765Ha to 0.3Ha in online application.

It to bring to your kind notice that the Parivesh Portal / System doesn't permit revision in Form A once the Forest clearance & Wildlife Clearance application is accepted and under process. The system says to withdraw the wildlife clearance application before making any changes in the area, a screen shot of the online application is attached herewith for ready reference, as Annexure-2. Similar query was raised by the Nodal Officer to revise the non-forest area vide letter dated 31.01.19 and it was informed categorically that the system is not allowing us to modify / change the area, being a technical issue; vide our letter dated 26.06.20; copies enclosed. Accordingly, the application was processed & agreed considering the technical issue with an advice to submit hard copies to field offices, vide email dated 28.08.20.


