- 1. Cost Benefit Analysis as per the guidelines issued under forest (Conservation) Act has not been furnished.
- Joint verification of land schedule of Sukurangi Chromite mines with forest department has not been done. Besides, the land schedule as furnished (Forest land involved) has not been signed by the Range Officer concerned.
- 3. Details enumeration list of trees has not been enclosed with the Diversion Proposal.
- 4. The detail land schedule indicating mouza, Khata no., plot no. etc. of non-forest land of 115.499 ha. involved in the project required to be submitted.
- The certificate furnished by Deputy Director Mines, Jajpur Road on utilization of non-forest land as furnished in Annexure – XXXI at Page-959 with the diversion proposal has not been signed by Deputy Director Mines, Jajpur Road which required to be complied.

You are requested to make necessary compliances to the above deficiencies at an early date for processing of the diversion proposals.
