Sir,

With reference to the above subject, we wish to provide you same more clarifications.

1)Thousands of devotees are visiting our Shri Subrahmanya Matha on daily basis in kukke Subrahmanya Kshetra. The above project not only aims at providing driniking water facility to the pilgrims but also caters the need of more than 100 Cows which are taking shelter in our **Goshalaa**.

As Submitted in my earlier letter efforts Have been made by the mutt to procure from non forest area by digging bore well which ultimately failed due to paucity of ground water resources. hence also we are unable to manage this high volume of waters scarcity out of water which will be supplied by panchayath or Temple. Small(river) glitter named kannadihole is flowing nearby math with small quantity of water. but the same highly polluted which is unfit for drinking purpose. So that there is no alternative source of water for drinking purpose.

Hence we are forced to explore the possibility of using water from natural stream flouring though the forest area.

However there is no map that is being prepared for using such alternative (from non forest resources).

2) We would like to provide information follows.

Sri Matha has 800 years of history.

One Sri. K Padmanabhacharya was appointed as Diwan to Srimatha approximately in the year 1952. As per his request, forest Department has leased 6-00 acres of forest land to him (documents may be available with forest Department.) To provide irrigation to this land he has fixed pipeline from this natural stream and the still existing. Hence from this it can be noticed that this pipe line is older than 1980. And it might have been repaired from time to time.

From the same place, we (to provide water to pilgrims who visit subrahmanya matha and cows) requested your office to provide permission to draw water from that place to our math. but so far no permission granted form your office.

Moreover, we bring it to your kind notice that the small construction across the stream roughly measuring 0.5 Mt was constructed in ancient days and mutt has not made any new structure in the proposed areas. The pipe laid down are also of olden days as submitted in my earlier letter.

Hence it is requested to process the proposals as per rules and oblige.
