
Subject:- Diversion of 4.6147 ha of forest land in favour of HPPWD, for the Construction of Gani to Bhorani Nala Road km. 0/00 to 7/200 within the jurisdiction of Nachan Forest Division Distt. Mandi HP (Online – Proposal No. FP/HP/Road/41345/2019).

Please refer to the Divisional Forest Officer, Nachan forest Division, EDS dated 23.03.2024 this office on the captioned subject vide which some observations have been raised on the proposal submitted for the approval of FCA.

It is intimated that this road has not been intimated under the violation list of 2183 to the Hon'ble High Court of HP. it has been conveyed that there used to be common way/ tradional old path on part of it and unknown local villager had started widening. Accordingly, a collective donation was made by local villager for construction/maintenance of the kutchra road for the rainy season, which is eminently required. The HPPWD authority has also conveyed in writing Joint inspection report that area of 2.7940 hectares of forest land has already been construction upon by the local people.


The principal Secretary (Forests to the Government of Himachal Pradesh vide office letter no. FFF-B-G(6)-9/2015 dated 15-11-2016 (copy attached) had directed that the cases of all such roads constructed in violation of the provisions of the Forest (Conservation) Act, 1980, which are not included in the list of 2183, constructed in violation of the provisions of the Forest (Conservation) Act, 1980 be accepted and processed for seeking approval under the said Act so that these can be regularized. Therefore, to regularize proposed road Gani to Bhorni Nala, the forest diversion case has been processed which is under process with this department.
