In reference to the EDS raised by Regional Office , MoEF & CC, Lucknow vide letter under reference, the point wise reply is as under :-

1	As per information provided at B-1 regarding earlier approvals, compliance of AIP issued in FP/RJ/TRANS/15911/2015 has not been submitted after a lapse of more than a year time.	Compliance of inprinciple approval issued in thr proposal no. FP/RJ/TRANS/15911/2015 has been already done on dated 10.01.18. The compliance has already sent to regional office on dated 2.5.18 . Now the compliance is pending with regional office Lucknow. Certificate of online summery is enclosed.
2	The extent of forest area mentioned in FRA certificates issued by DM, Ajmer & DM, Nagour do not match with the proposed area for diversion page 25 & 46 of the proposal.	Initial FRA was apply for diversion of 3.92 ha. of forest land having khasara no. 15,19,77,76,23,23/2476 &69 , the proposal was examined by DCF Ajmer. It is found that khasara no. 23/2476 & 69 are not related to forest department. Therefore the area of above two khasara not included in forest diversion proposal, the total forest land 3.01 ha. Proposed for diversion is included in FRA certificate. Similarly FRA was apply for diversion of 1.21 ha. Of forest land having khasara no. 425,448 bt the proposed was examined by DCF Nagaur but length of forest area applied for diversion of 0.91hec. The total forest land 0.91 hec. Included in the FRA Certificate.
