On scrutiny of your proposal and documents submitted online vide your proposal no: FP/AS/TRANS/142618/2021, dated 26/5/2021 for use of forest land measuring 18.028 Hectare for Diversion proposal of proposed 18.028 ha area of forest land for construction and commissioning of 132 kv transmission line from Agia GSS to Goalpara TSS at Rakhayashini PRF under Goalpara Forest Division reveals the following shortcomings and hence the same could not be processed for onward transmission. Necessary action may, therefore, be taken for rectification and submission of the following wanting documents and information:

C-(iii) – In the uploaded SOI toposheet (1:50,000 Scale) map, you have mentioned that out of a total of 33 nos. of towers, 4 nos. of towers (tower No. 11, 12, 12/1 and 12/2) falls outside the forest area. So, please upload a certificate/ document received from the competent authority in support of such clarification.

Additional Information:

1. An undertaking for the payment of the cost of Dwarf plantation in the non-judicial stamp paper to be uploaded.
2. The aerial distance of the proposed area from the nearest Tiger Reserve / National Park/Wildlife Sanctuary/Biosphere Reserve (To be taken from the concerned Divisional Forest officer) should be uploaded.
