I invite attention to the subject and references cited. It is to inform that through the reference 1st cited the statutory proformas in (7) sets has been along with the technical report with request to process and accord clearance for diversion of forest land for non-forest purpose for grant of Quarry Lease for Black over an extent of 8.000 Hectares in Compartment No.387 of Allamadugu R.F. Chittoor East Division, Vedurukuppam Mandal, Chittoor District under Section 2 of F.C. Act, 1980 for a period of 20 years infavour of M/s Sri Suryam Granites, Proptx: Smt. P. Sndhya Vani.

Through the reference 2nd cited the Prl. C.C.F. Hyderabad while returning the statutory proformas requested to furnish the remarks on the following short comings.

- M/s Surya Granites, has not submitted a certificate for providing documentary evidences in support of settlement of rights under RoFR Act, 2006 as stipulated in MoEF, GoI Lr.dt:03.08.2009.
- 2. The said company has not submitted a certificate to the effect that the black granite is not available outside the forest in that area.
- 3. The UA has not submitted their application through online as per the recent guidelines issued by the MoEF GoI.
- 4. While forwarding the application of the said company the DMG has not indicated whether the proposals were examined w.r.t. to the provisions of MMDR amendment Act, 2015 of GoI in selection of the application.

In this connection, through the reference 3rd cited the Asst. Director of Mines and Geology, Chittoor submitted remarks for the shortcomings as detailed below:

The applicant has submitted acknowledgement copy of online Registration Confirmation for applicant for seeking prior approval of Environment, Forest & Wildlife Clearances duly signed by the applicant.
