Execution of the license deed/Agreement between Executive Engineer (i) P.W.D. NH Div. Pali and representative of Power Grid corporation of India Limited. prior to Execution of work.

Performance Bank Guarantee @ Rs. 1,00,000/- per crossing is applicable (ii) in above locations and PGCIL will deposit the same through BGs before signing the agreement and execution of work.

All necessary clearances including Forest clearance etc. if any, be (iii) obtained by Power Gird Corporation from concerned department, if required.

The licensee (Power Grid Corporation) shall shift the transmission lines (iv) within 60 days (or as specified by PWD) from the date of issue of notice by the PWD to shift/relocate the lines, in case it is so required for the purpose of improvement/widening of the highway or construction of flyover/bridges and restore the highway/land to its original condition at its own cost and risk.

Power Grid Corporation shall be responsible for any damages of (v) highway property and repair at their own cost.

Power Grid Corporation shall be responsible to take all types of safety (vi) measures during construction and maintenance of over head power line etc.

- The required permission for crossing/diversion of traffic or any other (vii) statutory permission shall be obtained by the Power Grid Corporation before execution of the work.
- The Power Grid Corporation shall ensure that there should not be any hindrance either to the traffic movement or construction and maintenance of highway during execution of overhead crossing work of 400 KV HT line and all safety measures shall be taken at their own cost.
- Power Grid Corporation of India Limited shall relocate/shift the above (ix)HT line free of cost, if required by PWD for future improvement of above stretch of NH-89
- The Power Grid Corporation will not have any right on the land of the (x) National Highway.
- The Power Grid Corporation shall intimate District Collector concerned (xi) prior to execution of crossing.

The permission shall be subject to additional conditions that Executive Engineer PWD NH Division, Pali shall impose and take care to the stability and structural safety of the Bridge/structures etc. while execution of the work.
