This is with reference to the request made by the project proponent for renewal of consent granted by the Board under the Water (Prevention & Control of Pollution) Act, 1974.

The renewal of consent to operate granted to the project proponent vide no. CTOW/Fresh/SGR/2021/14787588 dated 08/02/2021 valid upto 07/08/2021 under the Water (Prevention & Control of Pollution) Act, 1974 is hereby renewed upto 01/09/2022 with the same conditions as mentioned therein and following specific conditions:

1. The project proponent shall ensure compliance of the mechanism/ guidelines prescribed by the Board vide circular no. 64 dated 02/02/2021 in true letter & spirit.
2. The project proponent shall regularly get cleaned the oil & grease trap, so that the wastewater can be effectively treated in the STP and the Oil & Grease so removed shall be disposed of in an environmentally sound manner.
3. The project proponent shall conform to the standards for treated waste water as laid down by the Board in circular vide no. SEE(HQ-1)/F.244/2011/271 Dated 10.10.2011 and as amended from time to time.
4. The project proponent shall develop more plantations along its periphery within one month for utilization of treated waste water during winter & grainy season and also utilize its treated wastewater onto land for plantation purposes in scientific manner, so as to avoid any stagnation in the plantation area.
5. The project proponent shall continue to comply with the provisions of the Solid Waste Management Rules, 2016 for disposal of solid waste generated from the palace.
6. The project proponent shall ensure segregation of the solid waste at source, facilitate collection of segregated waste in separate streams, handover recyclable material to either authorized waste pickers or authorized recyclers as prescribed in Solid Waste Management Rules, 2016. The bio-degradable waste shall be processed, treated and disposed of through composting or biomethanization within the premises as far as possible. The residual waste shall be given to the waste collectors or agency as directed by the local body.
7. The project proponent shall install water meter at tubewell, immediately.
8. The project proponent shall provide rainwater-harvesting system for recharging of ground water with roof top rain water.
9. The project proponent shall obtain permission from Punjab Water Regulation and Development Authority (PWRDA) for the abstraction of ground water.

All other contents shall remain unchanged. This letter shall remain appended with the consent issued vide no. CTOW/Fresh/SGR/2021/14787588 dated 08/02/2021 to the project proponent under the Water (Prevention & Control of Pollution) Act, 1974.
