Cost to be incurred on the above activities has to be given component wise. Details of dumping site including length, width and height of structures to be excavated must be mentioned.

Undertaking by the user agency has to be given to the effect that:

1. Muck management plan will be implemented by the user agency and in case of non implementation of plan, they will be liable to penalty/action at their cost.
2. The proposed dumping site is located away from river/stream/naala.
