

## DETAILED NOTE ON PROJECT

The telecom cables are always laid along the admitted RoW due to easy supervision, quick maintenance, and low cost of maintenance. The Applicant does not have to acquire land for this purpose as the road side land belongs to State Govt. Telangana State (but the existing Road is passing through Forest). Laying of Cable shall be done on a 40cm. width of surface land, & up to 1.2 metres of depth and near to the extreme road boundary (in exiting RoW) where alignment of trench will be done in such way that no tree will be required to be cut. The laying of telecom transmission cable along roadside is an agreed policy of the Applicant and Ministry of Surface Transport

This Optical Fibre Cable system will fulfill the needs of Telecommunication circuits and Wireless Broadband Services and other Data for the Government, Industries, Defense and Society. This telecom Infrastructure shall lead to growth in economy and hence more employment and better living conditions of the geography/state/Country.

This new scheme of laying optical Fibre Cable is most modern and state of art Technology in the field of Digital Telecommunication. Moreover the same cable will provide most of new value added services as well as it will cater for the needs of Integrated Services Digital Network.

## JUSTIFICATION FOR LOCATING THE PROJECT ON FOREST LAND

The Optical Fibre Cable is generally laid along the admitted RoW of State / National Highway roads. Such road side area is declared as the Protected Forest under the Indian Forest Act.

The area requested for the laying of the Optical Fibre Cable is the bare minimum considering the requirements and also considering the safety of the cables so laid. Since the telecommunication cables also carry the communication from the Government offices, Defence & Strategic establishments, and from the different industrial organizations apart from the general public, for the safety and confidentiality of the conversation so made it is not advisable to lay such important cables on the private land belonging to different parties.

The Cable alignment will be suitably diverted to avoid any cutting of trees and laid within the road land boundary by excavating a narrow trench of 40cms width. The same strip of trench will be reinstated to its original condition. It is also intimated that no structure will be erected on the cable route.
