

In spite of this office letter under ref (4) & (5) you have not submitted the following documents in connection your proposal for NOC permission for laying of AGL Natural Gas 200 mm (8" Dia) NB Carbon Steel Pipeline along the NH-27 left side from Rasara Bus Stop to Chirgaon By Pass Section, for Approx. 29.950 Km. (from Ch.1387+950 to Ch. 1417+900).

Therefore, you are once again requested to submit the following at the earliest as already been desired through this office letter ref (4) & (5) as referred above so that further action in the matter may be taken accordingly:-

- (1) In Line drawing of proposal file entry and exit points of Pipeline is not included.
- (2) Detail location of pipeline in RoW of NH Land is not clear in drawing.
- (3) Km. wise drawing showing culvert, service road, bridges should be submitted from which location pipeline is going to pass.
- (4) Old Circle rate is submitted along with proposal. It is requested to submit new circle rate duly verified by Municipal Authority. Area wise Circle rate is to be submitted parallel to NH.
