

Subject: Reply of Query raised (Dated 19.11.2018) in Forest Land Diversion Proposal of 16.49 Ha. of Bera Mouza falling in Kuya Colliery (OC) of Bharat Coking Coal Limited.

Dear Sir,

The reply of queries/shortcomings in Forest Land Diversion Proposal of 16.49 Ha. of Bera Mouza falling in Kuya Colliery (OCP) of Bharat Coking Coal Limited is appended below:

- 1. The proposal for diversion of 11.17 Ha. was submitted vide Proposal No. FP/JH/MIN/32906/2018 dated 02.04.2018 as per directives of your good office vide Letter No. 2089 dated 14.09.2016. Further, proposal was checked at Division and Range level and it was found that total notified forest remaining in Bera Mouza is 16.49 Ha. The same was communicated to us vide letter no 1094 dated 31.05.2019.
 - A total of 5.11 Ha. Jungle Jhari (JJ) land (As per RS Khatiyan) exists in Mouza Chandkuya i.e. in leasehold of Kuya Colliery (OC). The complete Land Schedule of Kuya Colliery certified by Circle Officers is uploaded as **additional information**. Land schedule of JJ Land based on authenticated Land Schedule by Circle Office, Govt. of Jharkhand is enclosed as **Annexure-I.**

The aforesaid JJ Land falls in Non-Coal Bearing Area and it will not be utilized for mining purpose. An undertaking regarding Payment of NPV of Jungle Jhari (JJ) Land is enclosed as **Annexure-II**.

- 2. It was clarified by Officials of Forest Department on 08th May' 2019 that NOC for GM Land is not required for Forest Land Diversion.
- 3. Application for obtaining Certificate under FRA'2006 has been submitted to DC Dhanbad. After obtaining aforesaid certificate, it will be submitted to State Forest Department.
- 4. The land is not finalized yet for Compensatory Afforestation (CA). After getting details of Land for CA, its DGPS Plan/KML will be submitted.
- 5. Joint Tree Enumeration List has been prepared and uploaded as Additional Information.

This is for your kind information and further necessary actions.





Subject: Regarding Proposal for Diversion of Remaining Protected Forest Land of Bera Mouza falling under leasehold of Kuya Colliery of Bastacolla Area, BCCL

Dear Sir,

As per the guidelines issued by MoEFCC vide Letter No 11-599/2014-FC dated 01.04.2015 (Copy enclosed), it was mandated to pay the NPV of the Forest Land (Part or in Full) falling in the Mining Lease and also obtain required approval from Central Govt. under section 2(ii) and 2(iii) of FC Act 1980 whichever the case may be.

In order to comply the aforesaid directive by MoEFCC, General Manager Bastacolla Area requested the office of Divisional Forest Officer to provide the amount of Net Present Value (NPV) to be paid in respect of 16.49 Ha. Protected Forest Land remaining in Bera Mouza (Copy enclosed).

In response to the above mentioned letter, the office of Divisional Forest Officer provided the NPV to be paid for the remaining protected forest land for 11.17 Ha. vide letter no 2089 dated 14.09.2016 (Copy of enclosed).

In pursuance to aforesaid letter issued by the office of Divisional Forest Officer, an application for diversion of 11.17 Ha. protected forest land of Mouza Bera falling in Kuya Colliery of M/s Bharat Coking Coal Limited for the purpose of Open Cast Mining was submitted vide Proposal No. FP/JH/MIN/32906/2018.

The aforesaid proposal was examined by Nodal Officer, FC Act 1980, State of Jharkhand and subsequently and communicated vide system generated email dated 22.09.2018 and, it advised BCCL to submit the Hard Copy of the Proposal to the office of concerned Divisional forest and concerned Office of Deputy Commissioner. Accordingly, duly signed hard copy of the proposal was submitted to above both offices in Dhanbad on 29.10.2018 and 27.10.2018 respectively.

In respect of the said proposal, queries regarding clarification of JJ Land falling in Mine Lease of Kuya, NOC of 'GM Land' falling in lease of Kuya issued by DC, Dhanbad, Certificate issued under FR Act 2006 by DC, Dhanbad, DGPS Plan of Compensatory Afforestation (CA) Land in Tundi Range and Joint Tree Enumeration List was received vide letter no. 1709 dated 19.11.2018 issued under signature of DFO, Dhanbad.

A meeting was held in the office of the Divisional Forest Officer to discuss the queries and issues faced by M/s BCCL in respect of the said proposal on 16.05.2019 and during the meeting, the records pertaining to the said application was revisited by DFO, Dhanbad and it

protected forest Land in Bera Mouza and 64.06 Ha. has already been handed over to M/s BCCL vide order dated 30.11.2015 (Copy enclosed) and as such the remaining remaining forest land in Bera Mouza stands to 16.49 Ha. M/s BCCL proposed for diversion of 11.17 Ha. in pursuance to the earlier communications received from the office of the Divisional Forest Officer. During the meeting, it was directed by Divisional Forest Officer to the representatives of M/s BCCL to modify the existing proposal to incorporate the left over 5.32 Ha. Land and thereby modify the application for diversion of 16.49 Ha. protected forest land.

In view of the above, it is requested to provide the NPV Calculation of 16.49 Ha. reaming forest land of Bera Mouza falling in Kuya Colliery at the earliest so that proposal can be modified and submitted at the earliest.
