As recommended by the Superintending Engineer PWD (R&B) Rajouri - Poonch Circle Rajouri vide No. SER/R&B/DB/2822-23 dated 29.01.2021, Administrative Approval is hereby accorded for above noted work for an amount of Rs.386.30 lacs (Rupees Three Hundred Eighty Six Lacs Thirty Thousand only).

The Administrative Approval is however, subject to the following conditions:-

The works shall be taken up for execution only after specific authorization of funds is made by the NABARD / Administrative Department.

2. The works shall be executed after observing all Codal formalities / procedures.

3. It must be ensured that there shall be no multi-source of funding or overlapping of schemes under different programmes.

The scheme shall be executed only after encumbrance's free land is available.

That the works are executed strictly as per provisions and specifications of the sanctioned estimates /. 4. NABARD guidelines.

6. Schemes / project shall be completed within stipulated time.

There is no time over-run or cost over-run involved in the project. Accord of Administrative Approval shall not be treated as an authority to spend money not provided for 7.

Quality control is mentioned in accordance with standards set under MORTH/IRC code.

9. Quality control is mentioned in accordance with standards set under work in the competent authority and 10. The detailed estimate of the work shall be technically sanctioned by the competent authority and proposals strictly devised and designed as per the relevant code of MORD /MORTH and IRC Manual /

Specifications as per the relevant schedule of rates is paid in accordance with the set codal 11. Any such item(s) not covered under relevant schedule of rates is paid in accordance with the set codal 12. The structural design of the cross drainage is got authenticated by the competent authority well before

the execution of work. The design shall also account for the latest HFL. the execution of work. The design shall also account for the falest HFL.

13. The NOC from the concerned regulatory Authorities such as forest department is obtained before the

commencement of the work.
