

The total length of road is to be formed is 3.450 KMs(in which the length of road is passing through forest 0/500 to 2/452 kms i.e,1.952 kms). The Pochampally and Godumalla Villages is having tribal population 350 and not having all weather road so far. In this regard the road from Rayadhari to Godumalla via Pochampally from 0/0 to 3/450 is proposed for Upgradation.

	in forest area		The Pochampally and Godumalla villages having the tribal population is about 350. The villages is not having an all weather road even after 75 years of Independence due to. its geographical location. The Pochampally and Godumalla are surrounded by the hills in its three sides. To connect the village with all weather roads there is no alternative to form the road from Rayadhari to Godumalla Via Pochampally for a length of 3.450 Kms and 1.952 kms road length is passing through Reserve forest area. There is an existing Gravel track 4.50 width the Upgradation of this road will not effect the existing forest growth, as 7.50 mts width is existing on proposed alignment.
