It is to inform that, the Chief Conservator of Forests, Guntur has submitted Wildlife Mitigation and Conservation plan for the proposed diversion of 5.94 ha. of forest land for rehabilitation and up-gradation of NH-167-B from km. 58/500 to km. 62/963 i.e., from Porumamilla to Chandrasekhara Puram two lane with paved shoulders in Udayagiri Range of Nellore Division. The details are as follows.

- The existing road from Km.57/1200 to Km.62/1950 is passing through Seetharampuram RF of Udayagiri Range of Nellore Division in SPS Nellore District of Andhra Pradesh.
- The proposed project road is 51.46 km away from Gundlabrahmeswaram Wildlife Sanctuary and 32.01 km away from Sri Lankamalleswara Wildlife Sanctuary.
- The following Schedule-I fauna have been observed in the study area.
  1. Tiger
  2. Leopard
  3. Sloth Bear
  4. Indian Peafowl
