

Numbers 295 and 296, southern and eastern sides of Survey Field Number 297 southern side of Survey Field Number 305, western and southern sides of Survey field Number 306, southern side of Survey Field Numbers 307 and 308 and meets the field tri-junction point of Survey Field Numbers 308, 309 and 292 of 10. Konasamudram village.

East.—Thence, the boundary runs generally towards south along the western side of Survey Field Number 309, northern, western and southern sides of Survey Field Number 311, southern side of Survey Field Number 310 of 10. Konasamudram village, western side of Survey Field Number 1 of 17, Nedigallu village till it meets the tri-junction point of Survey Field Number 1 of 17, Nedigallu village Survey Field Number 1 of 16. Nochili village and Survey Field Number 292 of 10. Konasamudram village.

South.—Thence, the boundary runs generally towards west along the northern and western sides of Survey Field number 1, western side of Survey Field Number 2 of 16, Nochili village and meets the tri-junction point of 16, Nochili village and 12. Kothakuppam village on the inter-state boundary between Tamil Nadu and Andhra Pradesh. Thence, it runs along the inter-State boundary till meets common boundary of village 15. Kodivalasa village and 12. Kothakuppam village.

West.—Thence, the boundary runs towards north along the eastern side of Survey Field Number 127 of 15. Kodivalasa village, southern, eastern and northern sides of Survey Field Number 293 of 12. Kothakuppam village, eastern sides of Survey Field Number 127 of 15, Kodivalasa village, southern, eastern and northern sides of Survey Field Number 226 of 12. Kothakuppam village, eastern and southern sides of Survey Field Number 125, northern side of Survey Field Number 124, eastern side of Survey Field Number 121 of 15. Kodivalasa village, southern and eastern sides of Survey Field Numbers 225/1, 2 and 3, eastern side of Survey Field Number 224, eastern and northern sides of Survey Field Number 223 of 12. Kothakuppam village, northern side of Survey Field Numbers 101 and 100, eastern side of Survey Field Numbers 99 and 98 of 15. Kodivalasa village till it meets the starting point.

RIGHTS ADMITTED

Right Number I.—Right is admitted to the public to worship the Anjenaya temple and also to use the water pit at the top of the hill. The temple is situated on the Northern side of the Forest Block. The area of the temple is 1.00 acre. Permission is also granted to the temple authorities to maintain and to carry out improvement works in the temple after obtaining necessary prior permission from Forest Department officials.

Right Number II.—Right of way is admitted to the public to use the foot path leading to the Anjenaya temple. The foot path enters the Forest Block on the western side of Survey Field Number 179 of 10. Kothakuppam village and runs towards west and reaches the temple. The length of

the foot path is 598.4 metres and its width is 4.00 metres. The bearings and distances of the foot path are as follows:—

Right Number III.—Right of way is admitted to the public to use the cart track leading from Chollappalli to Podatturpet. The cart track enters the Forest Block on the western side of Survey Field Number 223 of 12. Kothakuppam village and runs inside the Forest Block towards north and leaves the Forest Block on the Southern side of Survey Field Number 219 of 10. Konasamudram village. The length of the cart track is 414.2 metres and its width is 3.2 metres. The bearings and distances of the cart track are as follows:—
