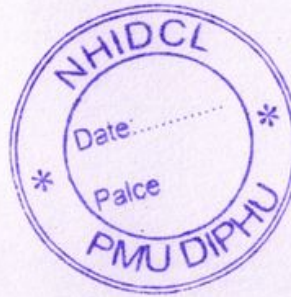
With reference to the Forest Clearance Proposal no FP/AS/ROAD/142711/2021 which was uploaded on date 27.05.21 was following the existing road alignment through the Daboka RF for which the Stage-I Part-I was approved by your kind office.

2. DFO, Nagaon South division, Hojai had requested to the NHIDCL to explore an alternative alignment to avoid excessive tree felling in Daboka RF vide letter no. FNST/A/4 Laning / Daboka RF/2021/3269-70 Dated 03.10.21, accordingly as per the recommendations of forest department, a joint site visit was carried out and a new route was selected and mutually accepted, this road alignment passes through the forest land with minor effects on the forest trees.


3. A meeting was held under chairmanship of DC Hojai, on 17/12/21 to study the effects on inhabitants, nature and also to meet technical requirements. The alignment in presence of Forest officials, NHIDCL officials, social activists and local politicians was discussed and analyzed. The MOM was recorded for the preferred alignment which entirely passes through forest land and was accepted by all and passed the DC, Hojai.

4. In view of the above, a New Forest Clearance Proposal no. FP/AS/ROAD/155754/2022 on date 24.05.22 has been uploaded for your kind consideration please.

5. In this regard, it is requested to withdraw the previously uploaded Forest Clearance Proposal no. FP/AS/ROAD/142711/2021 dated 27.05.21 and the new proposal as above be approved at the earliest please.
