Sir,

This is in reference to your letter u/r(1) vide which two options for the alignment of Patna-Sasaram road has been submitted as under:

Option I: From Suara (On NH-19) to Patar (Near Arrah) via Bikramganj, Piro & Garhani bypasses and further connecting to Patna ring Road at Sadisopur on right side by new Link road and connecting to Asni on Ara-Mohania Road.

Option-II: Green field Alignment from Suara (On NH-19) to Garhani (Nearly72km) and 10 km further along existing Alignment upto Patar (Near Arrah) and further connecting to Patna ring Road at Sadisopur on right side by new Link road and connecting to Asni on Ara-Mohania Road.

2. Based on the comparative analysis, Option-II has been found to be the most economical, technically feasible and futuristic option. The ACS-cum-PS, RCD, Govt. of Bihar has also consented to Option-II as the preferred alignment in the meeting held on 01.09.2020. Accordingly, in-principle approval is accorded to you to prepare DPR and submit report within a time period of 45 days from now. You are also requested to submit proposal for final approval of alignment plan by LAC at NHAI, HQ within next 3-4 days.


