PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Forest Department - Lease of forest land in Singanamane Minor Forest & Aldhara Reserve Forests, Shimoga District, in favour of the University of Mysore - revised orders.

GOVT. ORDER NO. FFD 31 FLL 83 BANGALORE, DATED 11TH MAY 1987

- READ: (i) G.O.No.FFD 108 FGL 76, dated 21-2-1979.
(ii) G.O.No.FFD 108 FGL 76, dated 17-12-1981
(iii) Letter No.B3.GFL.CI.45/76-77, dated 15-6-1983 and 9-3-1987 of the Chief Conservator of Forests(General), Bangalore.

PREAMBLE:-

In the Government Order dated 21-2-1979 read (i) above, sanction was accorded for lease of 250 acres of forest land, situated in Singanamane Minor Forest 230 acres, and 20 acres of land over-hanging Bhadra Reservoir situated partly in Aldhara Reserve Forest in favour of the University of Mysore for construction of Conference Hall, Guest House etc., and also for establishment of P.G. Course in B.R. Project, subject to certain conditions indicated therein. The period of lease of the aforesaid areas was fixed as 20 years as per Government Order dated:17.12.1981 read (ii) above:

The Chief Conservator of Forests (General), Bangalore in his letters dated:15.6.1983 and 9.3.87 read (iii) above has reported that the area of 20 acres granted, and falling within Aldhara Reserve Forest is thickly wooded and may not be leased out and the lease of land to the University may be confined only to 230 acres of land in Singanamane Minor Forests already made over to the University of Mysore and regarding which Registrar of the University is reported to paid the lease rent of Rs.75,000/- also and requested for modification of the earlier orders in respect of the areas referred to-

The aforesaid matter was further discussed in the meeting held on 17-2-1987 in the Chambers of the Education Secretary also, and it was decided that the University of Mysore may presently confine to the release of 230 acres, pending consideration of allotting an alternate area in lieu of the 20 acres sanctioned in Aldhara Reserve Forest earlier. Further it was also indicated that immediate necessary steps may be for signing of the requisite Agreement for 230 acres, and also eviction of encroachers in the area referred to.

O R D E R

In the circumstances, sanction is accorded to restrict the area of lease in favour of the University of Mysore to 230 acres of forest land in Singanamane minor

Forest sanctioned as per G. Nos. FFD 108 JGL 76, dated 21-2-1979 and 17-12-1981, subject to the terms and conditions specified therein.

The Chief Conservator of Forests (General), Bangalore should take necessary steps to execute the lease agreement in the matter, and also to evict the encroachers in the lease out area.
