5	In Part I the correct copy of map indicating alternate examined is not provided.	In Part-I the Alternative alignment already shows in Topo sheet and Digital Map.

6	The employment details provided in online Part I is seems incorrect. The states Govt may review the information and provide correct detail if required.	The correct employment detail now uploaded in Part-I.
7-	The FRA certificate is undated and the word NOT APPLICABLE IS mentioned against point A,B,C which is incorrect. The State Govt may submit revised FRA certificate without mentioning NOT APPLICABLE.	The corrected FRA certificate is now uploading.
8	The administrative and financial approval of the road is not opening in online Part I uploaded as an additional document.	The clear Administrative & Financial approval is uploaded now.
9	In Part II the details against working plan prescription of the area is wrongly filled.	In Part-II the correct working plan is uploading .
10	Details of wildlife is not provided in online Part II.	This point is not concern to this department.
